

# TRAFFIC MANAGEMENT ORDER

## THE LONDON BOROUGH OF RICHMOND UPON THAMES (WAITING AND LOADING RESTRICTION) (CIVIL ENFORCEMENT AREA) (AMENDMENT No. 19) ORDER 2009

Made: 22 June 2009

Coming into operation: 29 June 2009

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended, and all other enabling powers hereby make the following Order—

1. This Order shall come into operation on 29 June 2009 and may be cited as the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Amendment No. 19) Order 2009.
2.
  - (1) In this Order the expression “enactment” means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
  - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
  - (3) The Interpretation Act 1978(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Consolidation No. 8) Order 2008(c), as amended, shall have effect as though:-
  - (a) for the items numbered 79, 87A, 317, 355 and 384 in Schedule 1 to that Order there were substituted the items similarly numbered and set out in columns 1, 2 and 3 of Schedule 1 to this Order; and
  - (b) there were added to the items in Schedule 1 to that Order the items numbered 9B, 324A, 600A and 741A and set out in columns 1, 2 and 3 of Schedule 2 to this Order.

### **EXPLANATORY NOTE**

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order introduces waiting restrictions:-

(a) "no waiting at any time" in lengths of:-

Albury Close, Hampton;  
Broad Lane, Hampton;  
Bryanston Avenue, Whitton;  
Hanworth Road, Hampton;  
Hawkesley Close, Twickenham;  
Hounslow Road, Whitton;  
Kneller Road, Whitton;  
Ryecroft Avenue, Whitton; and  
Vicarage Road, Whitton;

and

(b) "no waiting between 11am and 12 noon on Mondays to Fridays inclusive" on the south side of Bryanston Avenue, Whitton.

### **STATEMENT OF REASONS**

The Council receives complaints throughout the year on matters of road safety caused by parked vehicles. These complaints can be received from residents, Councillors and bus and emergency services. These matters include poor sight lines at junctions, obstruction of footway crossing points, lack of suitable passing areas and reduced carriageway width restricting or preventing access for vehicles especially emergency service vehicles.

This Order is intended to improve road safety for all users by introducing waiting restrictions applying either at any time or for other specified hours. Similar restrictions have proved effective in locations elsewhere in the borough that previously suffered similar problems.

A previous order (2009/19) made in part some of the measures set out in the proposed order published on 13 February 2009. The Council has given further consideration to other measures set out in that proposed order, and has made certain modifications to those proposals. This order brings into force those other measures, as modified.

### **Broad Lane, Hampton, junction with Albury Close:**

Albury Close, both sides, 30 metres from junction;  
Broad Lane, north side, 10 metres from junction in both directions.

### **Bryanston Avenue, junction with Ryecroft Avenue, Whitton:**

Bryanston Avenue, both sides, 10 metres from junction;  
Ryecroft Avenue, east side, 10 metres from junction in both directions.

### **Bryanston Avenue, junction with Strathearn Avenue, Whitton:**

Bryanston Avenue, both sides, 10 metres from junction;  
Strathearn Avenue, west side, 10 metres from junction in both directions.

### **Colston Road, Sheen:**

Both sides, approximately 20 metres long, outside Nos 4-6 Colston Road.

### **Derby Road, Sheen:**

West side, approximately 70 metres long, from red route controls near Upper Richmond Road West to outside No 18 Derby Road.

East side, approximately 6 metres long, extend the existing double yellow lines near the garages opposite No 18 Derby Road.

### **Fearnley Crescent, junction with Stanford Close, Hampton:**

Stanford Close, both sides, for 7.5 metres from junction;  
Fearnley Crescent, east side, for distances of 10 metres and 7.5 metres from the junction.

### **Grasmere Avenue, Whitton:**

On the outside of the bend by Nos 7-17 Grasmere Avenue, approximately 40 metres overall.

### **Hawkesley Close, Twickenham:**

West side, for approximately 30 metres from Waldegrave Park, on the flank of No 77 Waldegrave Park;  
East side, for 7.5 metres from Waldegrave Park, on the flank of No 79 Waldegrave Park.

### **Hanworth Road, junction with Cannon Close, Hampton:**

Hanworth Road, north-east side, 10 metres from junction with Cannon Close in both directions.

### **Hanworth Road, junction with Nursery Gardens, Hampton:**

Hanworth Road, north-east side, 7.5 metres from junction outside No 320 Hanworth Road and for 16 metres from junction outside No 324 Hanworth Road.

### **Hounslow Road, in the vicinity of Kneller Road and Vicarage Road, Whitton:**

**Hounslow Road**, north-east side (adjacent to St Philip and St James church), from outside No 96 Hounslow Road to outside No 104 Hounslow Road;

**Hounslow Road**, south-west side (opposite side from the church and opposite Vicarage Road), from outside No 61 to outside No 67 Hounslow Road;

**Kneller Road**, both sides, approximately 20 metres from Hounslow Road to the “rugby zone” parking bays outside No 232 Kneller Road;

**Vicarage Road**, both sides, approximately 10 metres from Hounslow Road;

**Langridge Mews, Hampton:**

Both sides, extend existing double yellow lines at the junction with Oak Avenue for a further 6 metres (outside Nos 1-6 and Nos 53-58 Langridge Mews).

**Oak Avenue, junction with South Road, Hampton:**

South Road, both sides, 10 metres from junction;  
Oak Avenue, south-west side, 10 metres from junction outside No 45 Oak Avenue (the “Royal Oak” public house), and 12 metres from junction outside No 49 Oak Avenue.

1. The Council of the London Borough of Richmond upon Thames on the 22 June 2009 made the above Order under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order will be to:-
  - (a) introduce new or extend existing waiting restrictions "no waiting at any time" (double yellow lines) in various streets as detailed in Schedule 1 to this Notice; and
  - (b) introduce new waiting restrictions "no waiting between 11am and 12 noon, Mondays to Fridays" in Bryanston Avenue, Whitton as detailed in Schedule 2.
3. On 24 April the Council gave notice that it had deferred making a decision in respect of certain proposals for waiting restrictions, notice of which was given on 13 February 2009. The Council has given further consideration to those proposals, and made certain modifications to them. This order has the effect of bringing into force those proposals as modified.

Bryanston Avenue, both sides, 10 metres from junction;  
Strathearn Avenue, west side, 10 metres from junction in both directions.

### **Hanworth Road, junction with Cannon Close, Hampton:**

Hanworth Road, north-east side, 7.5 metres from junction with Cannon Close in both directions.

### **Hawkesley Close, Twickenham:**

West side, for approximately 30 metres from Waldegrave Park, on the flank of No 77 Waldegrave Park;  
East side, for 5 metres from Waldegrave Park, on the flank of No 79 Waldegrave Park.

### **Hounslow Road, in the vicinity of Kneller Road and Vicarage Road, Whitton:**

**Hounslow Road, junction with Vicarage Road**, north-east side (adjacent to St Philip and St James church), from outside No 96 Hounslow Road to a point opposite No 67 Hounslow Road;

**Hounslow Road, junction with Kneller Road**, north-east side (adjacent to St Philip and St James church), from a point opposite No 81 Hounslow Road to outside No 104 Hounslow Road;

**Hounslow Road**, south-west side (opposite side from the church and opposite Vicarage Road), from outside No 61 to outside No 67 Hounslow Road;
