TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (WAITING AND LOADING RESTRICTION) (CIVIL ENFORCEMENT AREA) (AMENDMENT No. 35) ORDER 2010

Made: 15 March 2010

Coming into operation: 22 March 2010

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended, and all other enabling powers hereby make the following Order—

- 1. This Order shall come into operation on 22 March 2010 and may be cited as the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Amendment No. 35) Order 2010.
- 2. (1) In this Order the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978**(b)** shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Consolidation No. 8) Order 2008(c), as amended, shall have effect as though:-
 - (a) for the items numbered 63, 267 and 767 in Schedule 1 to that Order there were substituted the items similarly numbered and set out in columns 1, 2 and 3 of Schedule 1 to this Order; and
 - (b) there were added to the items in Schedule 1 to that Order the item numbered 82A and set out in columns 1, 2 and 3 of Schedule 2 to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order introduces waiting restrictions ("no waiting at any time") in lengths of Beverley Gardens, Brook Gardens, Gipsy Lane and Warwick Drive, Barnes, including that part of Warwick Drive which forms the entrance to Beloe Close.

STATEMENT OF REASONS

The Council is proposing to extend the parking controls of the South Barnes CPZ into Brook Gardens, Warwick Drive and Gipsy Lane, Barnes. To allow some short-stay parking by non-residents, it is proposed that such a facility (with a maximum stay of 1 hour) be provided in Gipsy Lane, between its junctions with Upper Richmond Road and Beloe Close. To reduce the possibility of congestion during the morning peak hour, parking in these bays is to be prohibited between 7am and 10am. Double yellow lines ("no waiting at any time" restrictions) are being proposed at certain road junctions on grounds of road safety and at other places for the convenience of drivers and pedestrians.

This Order provides for the waiting restrictions.

Separate orders make provision for the amendments to the CPZ parking places and for the limited-time parking bays.

- 1. The Council of the London Borough of Richmond upon Thames on 15 March 2010 made the above Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended.
- 2. The general effect of the South Barnes Parking Places Amendment Order is to extend the area of the South Barnes controlled parking zone into the streets specified in the following table, and to introduce parking places as indicated, where parking during the controlled hours will be restricted for use by only holders of the type or types of permit specified:-

- 3. The general effect of the **Free Parking Places**, **Limited Time Amendment Order** is to introduce 7 limited time parking bays in Gipsy Lane (between Upper Richmond Road and Warwick Drive) operating between 10am and 4pm on Mondays to Fridays inclusive where vehicles may wait, free of charge, for a maximum period of 1 hour, and with no return being permitted within 1 hour. Parking in these bays will be prohibited between 7am and 10am on these days.
- 4. The general effect of the **Waiting and Loading Restriction Amendment Order** is to introduce waiting restrictions:-
 - (a) "no waiting between 7am and 10am on Mondays to Fridays inclusive" in the free parking places specified in paragraph 3 above; and
 - (b) "no waiting at any time" in the locations specified in Schedule 2 to this Order.
- 5. The hours of control of the South Barnes CPZ are between 10am and noon on Mondays to Fridays inclusive.
- 6. Residents will be eligible to apply for a resident's parking permit or residents' visitor's permits if they live at any of the addresses specified in Schedule 1 to this Notice.

Business users with a business address as specified will be able to apply for a business permit.

- 7. The charge for a resident's or business parking permit will be the same as existing for this zone, details of which are available on request. The charge is dependent on the amount of CO2 gas emitted by the vehicle for which the permit is issued (or, for vehicles first registered before March 2001, on the size of its engine), and an additional charge is payable for the second and any subsequent permit issued to any one household or business.
- 8. The charge for a book of 10 residents' visitor's permits is £11.00, and each permit will be valid for the two-hour period specified in paragraph 5 above. Residents aged 60 and above are entitled to a 50% discount. Each household is restricted to no more than 2 books at any time and to a maximum of 12 books in any period of 12 months.
- 9. Copies of the Orders, which will come into operation on 22 March 2010, plans showing the location and effect of the Orders and the Council's Statement of Reasons for making the Orders can be inspected for a period of six weeks from the date of this Notice, quoting Reference 24/10, at:-

- 11. Persons wishing to question the validity of the Orders or any of their provisions on the grounds that they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Orders were made, apply for the purpose to the High Court.

- 3. The general effect of the **South Barnes Parking Places Amendment Order** will be to introduce parking places in the following streets, where parking during the controlled hours will be restricted for use by only holders of the type or types of permit specified in this table:-

The general effect of the **Free Parking Places, Limited Time Amendment Order** will be to introduce 7 limited time parking bays in Gipsy Lane (between Upper Richmond Road and Warwick Drive) operating between 10am and 4pm on Mondays to Fridays inclusive where vehicles may wait, free of charge, for a maximum period of 1 hour, and with no return being permitted within 1 hour. Parking in these bays will be prohibited between 7am and 10am on these days.
- 5. The general effect of the **Waiting and Loading Restriction Amendment Order** will be to introduce waiting restrictions:-
 - (a) "no waiting between 7am and 10am on Mondays to Fridays inclusive" in the free parking places specified in paragraph 3 above; and
 - (b) "no waiting at any time" in the locations specified in Schedule 2 to this Order.
- 6. The Council gave notice on 28 November 2008 of its proposals to merge the existing controlled parking zones of North Barnes (Zone "B1"), Barnes Village (Zone "CB1") and South Barnes (Zone "CB2") into a common zone to be known as the Barnes controlled

parking zone, with the indicative letters "B1". For the purpose of this notice, the extension of the parking controls specified in paragraph 2 above are being presented as an amendment to the South Barnes CPZ. However, if the merging of three zones is completed before the proposals described in this notice come into effect, the relevant order will be an amendment to the newly-created Barnes CPZ.

- 7. The hours of control of the South Barnes CPZ and of the proposed Barnes CPZ are between 10am and noon on Mondays to Fridays inclusive.
- 8. Residents will be eligible to apply for a resident's parking permit or residents' visitor's permits if they live at any of the addresses specified in Schedule 1 to this Notice. Business users with a business address as specified will be able to apply for a business permit.
- 9. The charge for a resident's or business parking permit will be the same as existing for this zone, details of which are available on request. The charge is dependant on the amount of CO₂ gas emitted by the vehicle for which the permit is issued (or, for vehicles first registered before March 2001, on the size of its engine), and an additional charge is payable for the second and any subsequent permit issued to any one household or business.
- 10. The charge for a book of 10 residents' visitor's permits is £11.00, and each permit will be valid for the two-hour period specified in paragraph 6 above. Residents aged 60 and above are entitled to a 50% discount n the charge. Each household is restricted to no more than 2 books at any time and to a maximum of 12 books in any period of 12 months.
