Barnes CPZs Review
Controlled parking zone (CPZ) consultation – Brook Gardens, Barnes

Last year as part of the above review, the Council undertook a consultation with residents and businesses of the existing CPZs in Barnes seeking their views primarily on merging three CPZs in Barnes. The consultation showed support for the merging of zone B1 (North Barnes CPZ), zone CB1 (Barnes Village), and zone CB2 (South Barnes CPZ). Proposals are being formally advertised on Friday 28 November 2008 to merge these three CPZs into a new Barnes CPZ along with a number of other minor changes to the CPZ.

As part of the review, opportunity is being taken to seek the views of residents of Brook Gardens to see if they would wish to have the CPZ extended to their road. Dependant on the outcome of the above-mentioned formal advertisement to merge the three CPZs in Barnes, any CPZ introduced in this area would either be as part of the existing South Barnes CPZ or as part of the newly created Barnes CPZ both of which are subject to operate Monday to Friday, 10am to Noon.

Enclosed is a consultation document together with a questionnaire for you to fill in. Please read the document prior to completing the questionnaire and return it in the prepaid envelope by **Monday 22 December 2008**. It is important for us to know your views in order to make an informed decision.
