

## LICENSING ACT 2003

### New and variation premises licence applications currently open to representation as at 22 May 2009

The Licensing Authority is now receiving applications for premises licences. The table below shows all the applications for new premises licences and variations of existing licences. For variation applications, only licensable activities being varied are shown. Interested parties (such as residents living in the vicinity of the premises) and responsible authorities (such as the police) can object to these applications.

The detail shown in the following table is limited to the opening hours applied for and the licensable activities. The hours for each licensable activity will be equal to or shorter than the opening hours. The full applications can be inspected at the Consumer Protection Offices, 7b Parkshot, Richmond, TW9 2RT during office hours, Monday to Thursday 09.00 to 17.15 and Friday 09.00 to 17.00, at The Civic Centre 44 York St, Twickenham TW1 3BZ Ground Floor reception during office hours, Monday to Friday 09.00 to 16.30 and at Richmond Reference Library, Old Town Hall, Whittaker Avenue, Richmond TW9 1TP during opening hours Monday 9.30am -6.00pm, Tuesday 9.30am - 5.00pm, Wednesday 9.30am - 8.00pm, Thursday 9.30am - 6.00pm, Friday 9.30am - 6.00pm, Saturday 9.30am - 5.00pm.

To make representations (objections) against any of the applications, parties should email to [licensing@richmond.gov.uk](mailto:licensing@richmond.gov.uk) or write to the Head of Licensing, 7b Parkshot, Richmond, TW9 2RT by the last date for representations as specified on the notice. Representations must be relevant to at least one of the four licensing objectives which are:-

- 1) Prevention of crime and disorder
- 2) Public safety
- 3) Prevention of public nuisance
- 4) Protection of children from harm

Licensable activities applied for are represented by the key below:-

**A**-Plays, **B**-Films, **C**-Indoor sporting events, **D**-Boxing or wrestling entertainment,  
**E**-Live music, **F**-Recorded music, **G**-Performance of dance,  
**H**-Anything of a similar description to that falling within **(E)**, **(F)** or **(G)**  
**I**-Provision of facilities for making music **J**- Provision of facilities for dancing  
**K**-Provision of facilities for entertainment of a similar description to that falling within **(I)** or **(J)**  
**L**-Late night refreshment  
**M**- Supply of alcohol  
**N**-Adult Entertainment or Services, activities, other entertainment that may give rise to concern in respect of children
