Your business can receive certification for each of the six BS8555 phases. Each consists of specific requirements, making implementation more manageable:

1. Commitment and establishing the baseline

3. Developing objectives, targets, and programmes
4. Implementation and operation of the EMS
5. Checking, audit and management review
6. EMS acknowledgement (equivalent to ISO14001 or EMAS)

This training course covers phases 1-3. Businesses typically seek training on phases 4 and 5 at a later stage, and can be available as an additional one day training course. Phase 6 is the progression towards accreditation according to the international ISO14001 or EMAS standards. To become accredited, you must pay for an inspection by a third-party UKAS inspection body.
