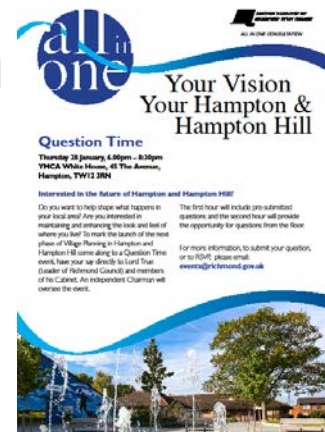

What is a Quietway?

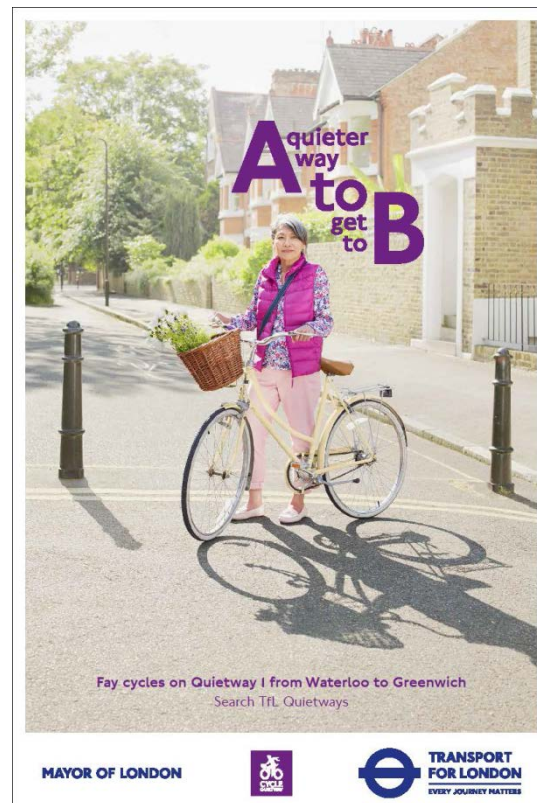
- TfL led initiative aimed at novice or less confident cyclists, or those not wanting to cycle in heavy traffic/on main roads and are happy with a more leisurely pace.
- Radial and orbital routes predominantly on quiet back streets, through parks, along canal towpaths. Some short sections along/across major roads are inevitable. Investing in providing comfortable cycling conditions at these locations.
- Quietways criteria:
 - Directness and Cohesion
 - Attractiveness
 - Network impact
 - Buildability
 - Political support
 - Network prioritisation and phasing



Wayfinding and marketing



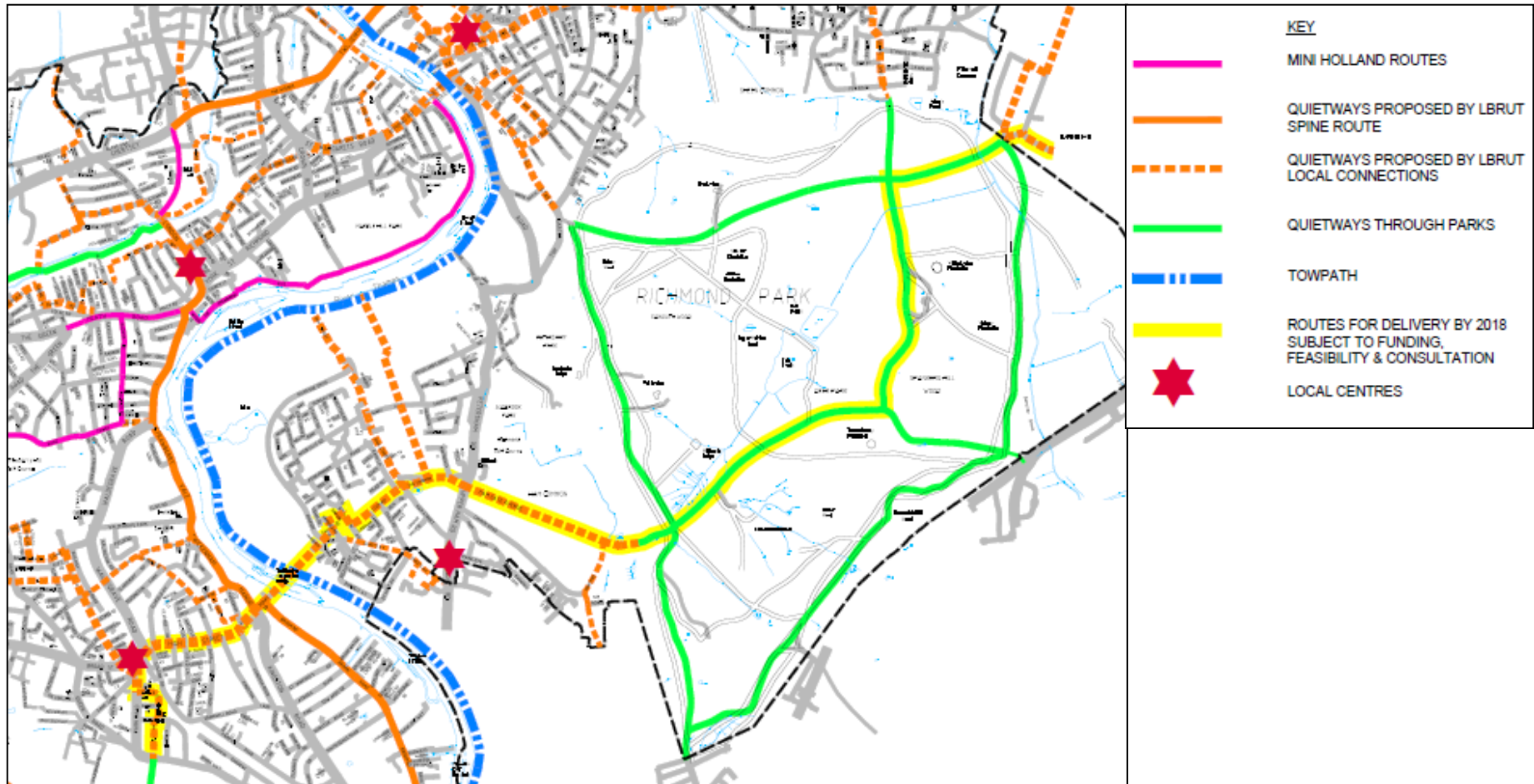
- Range of measures to be implemented depending on requirements on each street (eg improved crossings, cycle logos, cycle lanes, 2 way cycling on one way streets, filtered permeability etc)
- Designed to benefit pedestrians and other road users too, not just cyclists
- Consistent wayfinding signage across London (see left)
- Scheme and marketing aimed at broad cross section of people (see poster on right)



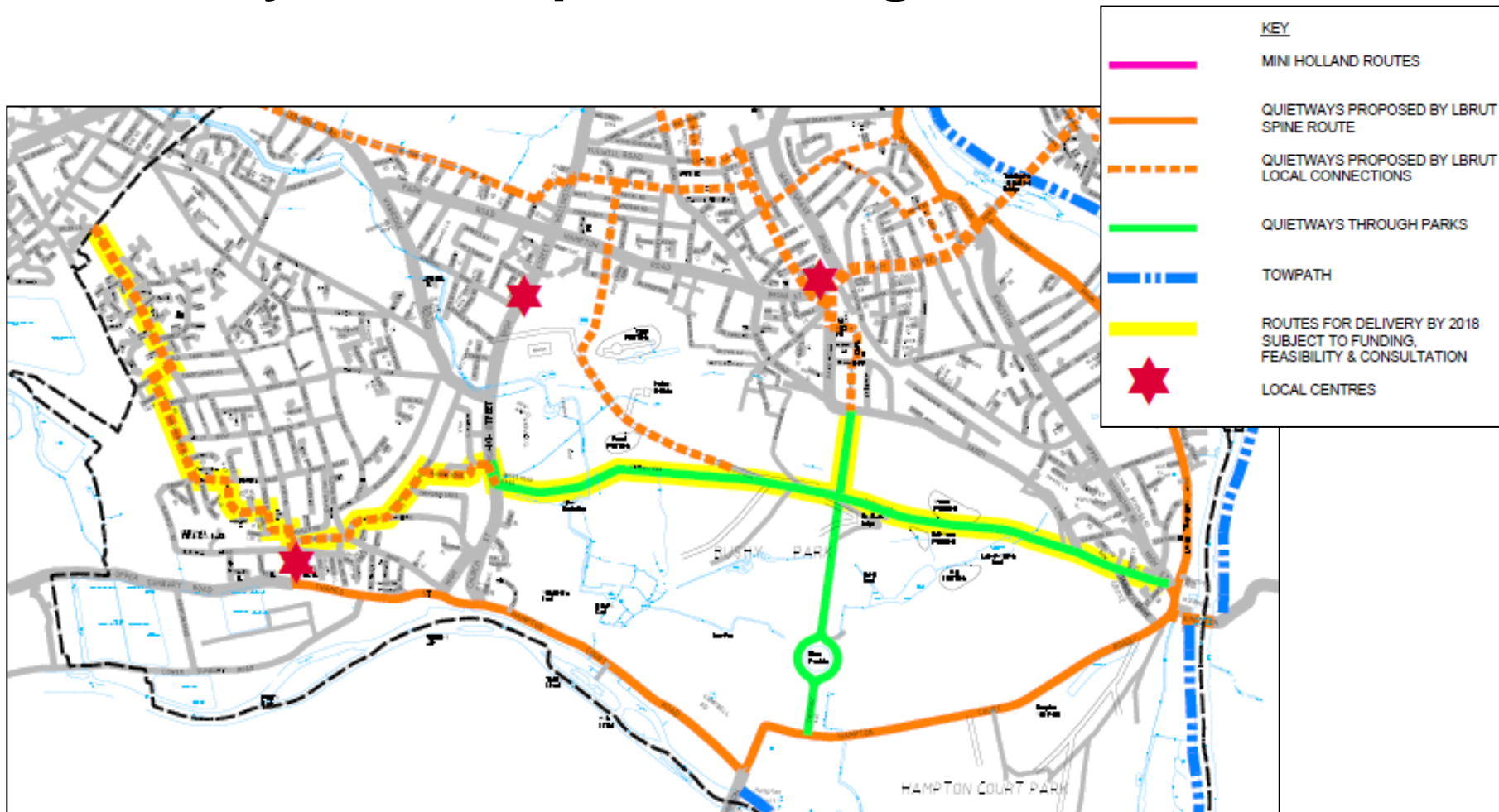
Where are the routes in LB Richmond?

- As part of the Council's draft Cycling Strategy, a proposed network of cycle routes will be put forward;
- TfL has agreed to fund Quietways 1 and 2 as part of 'Phase 2' of the Quietway programme;
- The Council has chosen to use some of its TfL LIP funding to undertake some initial feasibility work on a further two routes (Quietways 3 and 4) this year (by April 2016), with a view to seeking further funding for these if they are viable.

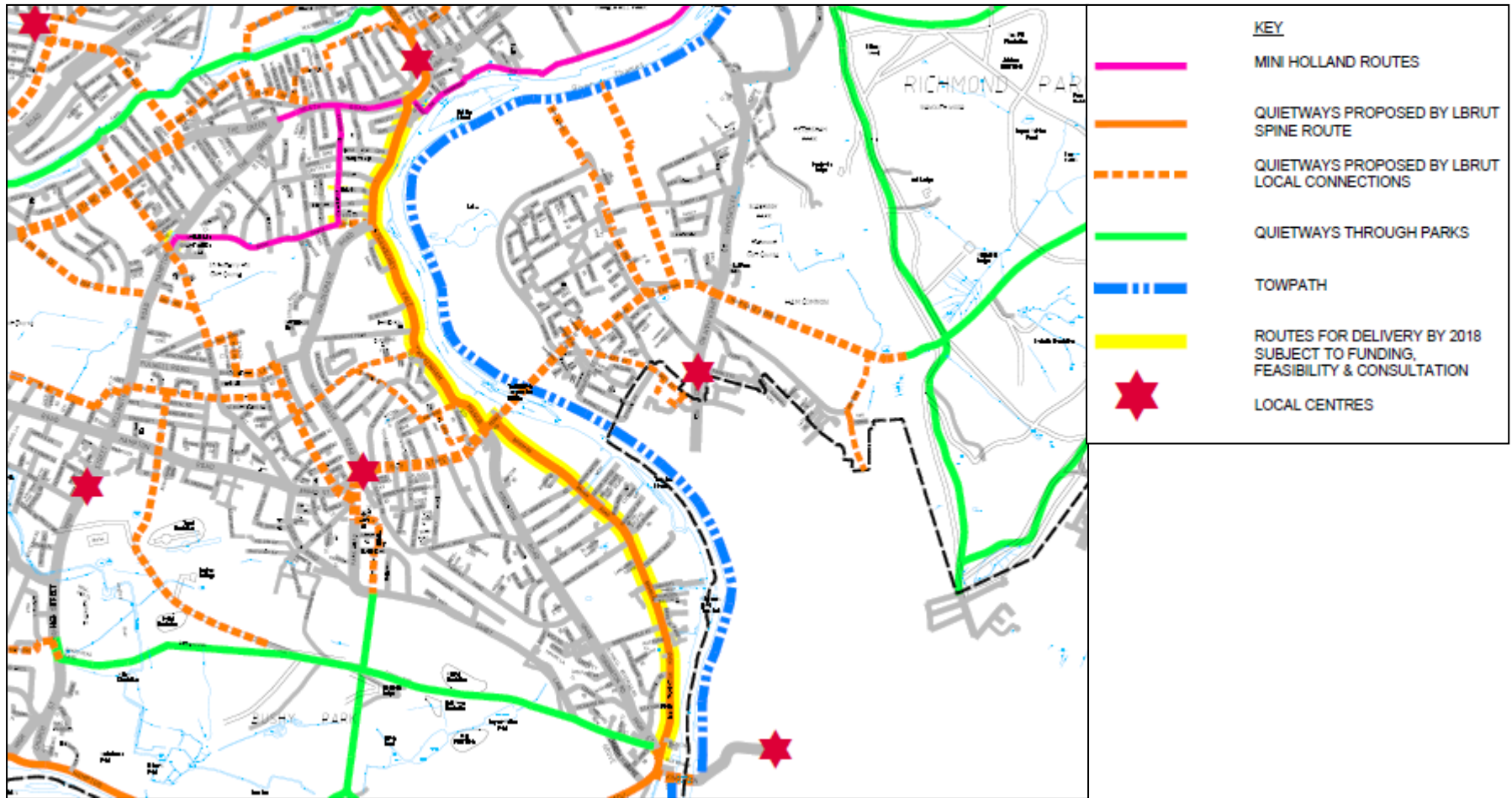
Quietway 1 – Teddington to Wandsworth Common

Quietways programme – provisional timetable

For Quietways 1-4:

- 1) First stage of work (Jan-Mar 2016)** - Engagement with Ward Members and cycle groups to discuss route alignments and types of measures that may be required along routes;
- 2) Discussion with TfL (April 2016)** - To check our ideas meet their criteria and are consistent with other Quietways across London;

For Quietways 1 and 2 (possibly Q3/4, subject to feasibility/funding):

- 3) Consultation with wider community on concept (May/June 2016)** - To consult community on alignments and the types of measures that we think are required to make routes attractive to less confident cyclists
- 4) Further design work (Summer - Autumn 2016)**
- 5) Further consultation on detailed proposals (Autumn/Winter 2016/17)**
- 6) Implementation (2017)**
