TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (WAITING AND LOADING RESTRICTION) (CIVIL ENFORCEMENT AREA) (AMENDMENT No. 10) ORDER 2008

Made: 13 October 2008

Coming into operation: 20 October 2008

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended, and all other enabling powers hereby make the following Order—

- 1. This Order shall come into operation on 20 October 2008 and may be cited as the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Amendment No. 10) Order 2008.
- 2. (1) In this Order the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978**(b)** shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Consolidation No. 8) Order 2008(c), as amended, shall have effect as though for the items numbered 25 and 469 in Schedule 1 to that Order there were substituted the items similarly numbered and set out in columns 1, 2 and 3 of the Schedule to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order introduces waiting restrictions ("no waiting at any time") in parts of Ashburnham Road and Mowbray Road, Ham.

STATEMENT OF REASONS

This Order introduces waiting restrictions "no waiting at any time":-

- (a) in Ashburnham Road, Ham at its right-angled corner between Broughton Avenue and Croft Way outside St Richards Church, on one side of the road only closest to the church, and for distances of 26 metres and 35 metres (measured from the corner towards Broughton Avenue and Croft Way respectively). The waiting restrictions will prevent dangerous parking, thereby improving sight lines for drivers and so contributing to road safety.
- (b) in Mowbray Road, Ham on its north-eastern side, other than a gap outside Nos 19-25 Mowbray Road, and for all of the turning head. This follows a survey of local residents. The restrictions, together with a section of footway parking exemption outside Nos. 19-25 Mowbray Road are intended to maximise the amount of unrestricted parking (including space on its south-western side) whilst maintaining sufficient width of carriageway for emergency service vehicles and other road users to gain access for the full length of this cul-de-sac.

MOWBRAY ROAD, HAM

(Reference 73/08)

- 1. The Council of the London Borough of Richmond upon Thames propose to make the above Order under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Order will be to introduce waiting restrictions "no waiting at any time" in Mowbray Road, Ham as specified in the Schedule to this Notice.
- 3. For the distance of 21 metres in Mowbray Road referred to in paragraph (a) of the Schedule, vehicles parked partly on the footway and within the marked area of that footway will be exempted from the general prohibition of parking on footways as provided for by Section 15 of the Greater London Council (General Powers) Act 1974.
- 4. These proposals are in place of those proposed on 29 February 2008. Pending the Council's consideration of any objections received pursuant to paragraph 5 below, the restrictions indicated by yellow line road markings already in place outside Nos 3-37 Mowbray Road and Nos 24-34 Mowbray Road are suspended.

WAITING RESTRICTIONS OUTSIDE ST RICHARDS CHURCH

- 7. The Council of the London Borough of Richmond upon Thames proposes to make the above Order under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Traffic Management Act 2004.
- 8. The Council apologizes that the road markings (double yellow lines) have already been placed in the section of Ashburnham Road to which this notice relates. The restrictions will not be enforced until the statutory process of consultation and consideration of objections has been completed, and a further notice issued to confirm that the proposed order, as above, has been made.
- 9. The general effect of the Order will be to introduce waiting restrictions "no waiting at any time" in the length of Ashburnham Road specified in the next paragraph.
- 10. The length of Ashburnham Road affected is at its right-angled corner between Broughton Avenue and Croft Way outside St Richards Church, on one side of the road only closest to the church, and for distances of 26 metres and 35 metres (measured from the corner towards Broughton Avenue and Croft Way respectively).
- 11. Copies of the proposed Order, a plan showing the location and effect of the proposals and the Council's Statement of Reasons for proposing to make the Order can be inspected, quoting Reference 69/08, at:
 - (a) Ham Library, Ham Street, Ham, Surrey TW10 7HR during opening hours, and
 - (b) the Civic Centre (Second Floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays.

ASHBURNHAM ROAD and MOWBRAY ROAD, HAM

(Reference 80/08)

- 1. The Council of the London Borough of Richmond upon Thames on 13 October 2008 made the above Orders under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended.
- 2. The general effect of the Order is to introduce waiting restrictions "no waiting at any time":-
 - (a) in Ashburnham Road, Ham at the right angle corner outside St Richards Church (one side of the road only, nearest to the church); and
 - (b) in Mowbray Road, Ham, on the north-east side (except for a length of 21 metres outside Nos 19-25 Mowbray Road) and for all of the turning head.
- 3. The footpath occupying the length of 21 metres referred to in paragraph 2 above will be exempt from the general prohibition of footway parking in London for a width of 300 millimetres throughout.
- 4. Copies of the Order, which will come into operation on 20 October 2008, plans showing the location and effect of the Order and the Council's Statement of Reasons for making the Order can be inspected for a period of six weeks from the date of this Notice, quoting Reference 80/08, at:-
 - (a) Ham Library, Ham Street, Ham, Surrey TW10 7HR during opening hours; and
 - (b) the Civic Centre (Planning Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays.

- 6. Persons wishing to question the validity of the Order or any of its provisions on the grounds that it or they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Orders were made, apply for the purpose to the High Court.
