

TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (WAITING AND LOADING RESTRICTION) (CIVIL ENFORCEMENT AREA) (AMENDMENT No. 2) ORDER 2008

Made: 7 July 2008

Coming into operation: 14 July 2008

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984**(a)**, as amended by the Local Government Act 1985**(b)**, the New Roads and Street Works Act 1991**(c)**, the Traffic Management Act 2004**(d)** and all other enabling powers hereby make the following Order—

1. This Order shall come into operation on 14 July 2008 and may be cited as the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Amendment No. 2) Order 2008.
2.
 - (1) In this Order the expression “enactment” means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978**(e)** shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Consolidation No. 8) Order 2008**(f)**, as amended, shall have effect as though:-
 - (a) for the item numbered 516 in Schedule 1 to that Order there were substituted the item similarly numbered and set out in columns 1, 2 and 3 of Schedule 1 to this Order; and
 - (b) there were added to the items in Schedule 1 to that Order the item numbered 603A and set out in columns 1, 2 and 3 of Schedule 2 to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order introduces waiting restrictions ("no waiting at any time") in lengths of Park Road, and St James's Avenue, Hampton Hill.

STATEMENT OF REASONS

This Order introduces waiting restrictions in Park Road, and St James's Avenue, Hampton Hill. These restrictions are proposed in conjunction with certain highway works, which include a build-out of the kerb-line on one side of Park Road and the realignment of an existing pedestrian refuge at that point. The waiting restrictions are intended to prevent dangerous parking in Park Road at its junction with St James's Avenue, and provide additional sight-lines for pedestrians using the crossing. As this location is on a well-established route for pedestrians to the nearby Hampton Hill Junior School, the proposed waiting restrictions will improve conditions for pedestrians and contribute to the road safety in the vicinity.

2. The general effect of the Order will be to introduce waiting restrictions "no waiting at any time" at the junction of Park Road, Hampton Hill with St James's Avenue, as specified in the Schedule to this Notice.
