
TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (WAITING AND LOADING RESTRICTION) (CIVIL ENFORCEMENT AREA) (AMENDMENT No. 7) ORDER 2008

Made: 15 September 2008

Coming into operation: 29 September 2008

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended, and all other enabling powers hereby make the following Order—

1. This Order shall come into operation on 29 September 2008 and may be cited as the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Amendment No. 7) Order 2008.
2.
 - (1) In this Order the expression “enactment” means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Consolidation No. 8) Order 2008(c), as amended, shall have effect as though:-
 - (a) for the items numbered 162, 176, 282, 286, 385, 446, 452 and 664 in Schedule 1 to that Order there were substituted the items similarly numbered as set out in columns 1, 2 and 3 of Schedule 1 to this Order; and
 - (b) there were added to Schedule 1 to that Order the items numbered 9A, 18A, 72A and 820 as set out in columns 1, 2 and 3 of Schedule 2 to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order introduces:-

- (a) waiting restrictions “no waiting at any time”:-
 - (i) in the north-east to south-west arm of Andover Road, Twickenham at its junctions with the north-west to south-east arm (leading to Camac Road) and the south-east to north-west arm;
 - (ii) at the junction of Andover Road, Mereway Road and Gould Road;
 - (iii) at the junction of Gould Road / Crane Road with May Road;
 - (iv) at the junction of Gravel Road with May Road;
 - (v) in Colne Road at its junctions with Briar Road, Mereway Road, May Road, Crane Road and Albion Road;
 - (vi) at the junction of May Road with Albion Road;
 - (vii) in Staines Road at its junctions with Briar Road and Knowle Road;
 - (viii) along a part of Albion Road near its junction with May Road; and
 - (ix) for the whole of the un-named road linking Albion Road with Colne Road by Nos 10 and 12 Albion Road and Nos 79 and 93 Colne Road; and
- (b) waiting restrictions “no waiting on Mondays to Fridays inclusive between 8.30am and 6.30pm”:-
 - (i) at the south-western limit of Colne Road in place of a footway parking exemption.

STATEMENT OF REASONS

The waiting restrictions “no waiting at any time” will prevent dangerous and obstructive parking at the junctions and in the lengths of streets affected, will improve sight lines for drivers and thereby contribute to road safety.

The single yellow line waiting restriction in Colne Road will prevent obstructive parking during business hours.

1. The Council of the London Borough of Richmond upon Thames propose to make the above Orders under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.
2. The general effect of the **Waiting and Loading Restriction Order** will be to:-
 - (a) introduce waiting restrictions "no waiting at any time" in parts of:-
 - (i) Albion Road including the un-named road linking Albion Road with Colne Road by Nos 10 and 12 Albion Road and Nos 79 and 93 Colne Road;
 - (ii) Colne Road, from its junction with Mereway Road towards its south-western limit; and
 - (iii) Knowle Road, at its junction with The Green, Twickenham (as specified in Schedule 1); and
 - (iv) at the junction of Albion Road with Colne Road;
 - (v) at two junctions of different arms of Andover Road;
 - (vi) at the junction of Briar Road with Staines Road;
 - (vii) at the junction of Colne Road with Briar Road;
 - (viii) at the junction of Gould Road with May Road;
 - (ix) at the junction of May Road with Gravel Road;
 - (x) at the junction of May Road with Albion Road;
 - (xi) at the junction of Mereway Road with Andover Road and with Gould Road; and
 - (xii) at the junction of Mereway Road with Colne Road; and
 - (b) introduce a new waiting restriction "no waiting on Mondays to Fridays inclusive between 8.30am and 6.30pm" in:-
 - (i) Colne Road at its south-western limit, in place of a footway parking exemption; and
 - (ii) May Road, the west side, at the access to Knights Place between Nos 16 and 18 May Road (both as specified in Schedule 2).
3. The general effect of the **Free Parking Places Order** will be to introduce a free parking bay (space for two cars) in Knowle Road, Twickenham where waiting will be permitted for a maximum stay of 20 minutes on Mondays to Sundays inclusive between 8.30am and 6.30pm, with no return permitted within one hour (as specified in Schedule 3).
4. The scheme will also introduce footway parking exemptions on the south side of Albion Road between its junction with May Road and Knowle Road.
5. Copies of the Draft Orders, plans showing the location and effect of the proposals and the Council's Statement of Reasons for proposing to make the Orders can be inspected, quoting Reference 18/08, at:-

1. The Council of the London Borough of Richmond upon Thames on 15 September 2008 made the above Orders under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended.
2. The general effect of the **Waiting and Loading Restriction Order** is to:-
 - (a) introduce waiting restrictions "no waiting at any time" in parts of:-
 - (i) Albion Road including all of the un-named road linking Albion Road with Colne Road by Nos 10 and 12 Albion Road and Nos 79 and 93 Colne Road;
 - (ii) Colne Road, from its junction with Mereway Road towards its south-western limit and outside Nos 79-97 Crane Road; and
 - (iii) Knowle Road, at its junction with The Green, Twickenham (items (i), (ii) and (iii) are further specified in Schedule 1); and
 - (iv) at the junction of Albion Road with Colne Road and Knowle Road;
 - (v) at two junctions of different arms of Andover Road;
 - (vi) at the junction of Briar Road with Staines Road;
 - (vii) at the junction of Colne Road with Briar Road, with May Road and with Crane Road;
 - (viii) at the junction of Gould Road with May Road;
 - (ix) at the junction of May Road with Gravel Road;
 - (x) at the junction of May Road with Albion Road;
 - (xi) at the junction of Mereway Road with Andover Road and with Gould Road; and
 - (xii) at the junction of Mereway Road with Colne Road;
 - and
 - (b) introduce a new waiting restriction "no waiting on Mondays to Fridays inclusive between 8.30am and 6.30pm" in Colne Road at its south-western limit, in place of a footway parking exemption (as specified in Schedule 2).
3. The general effect of the **Free Parking Places Order** will be to introduce a free parking bay (space for two cars) in Knowle Road, Twickenham where waiting will be permitted for a maximum stay of 20 minutes on Mondays to Sundays inclusive between 8.30am and 6.30pm, with no return permitted within one hour (as specified in Schedule 3).
4. The proposal, notice of which was given on 29 February 2008, to introduce a single yellow line restriction in May Road at the access to and from Knights Place has been withdrawn. In its place, the Council will introduce a double yellow line restriction by way of an experimental scheme, notice of which is given separately.
