

## PARKING PLACES ORDER

### THE LONDON BOROUGH OF RICHMOND UPON THAMES (RICHMOND TOWN) (PARKING PLACES) (AMENDMENT No. 1) ORDER 2009

Made: 9 March 2009

Coming into operation: 16 March 2009

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended, and all other enabling powers hereby make the following Order—

1. This Order shall come into operation on 16 March 2009 and may be cited as the London Borough of Richmond upon Thames (Richmond Town) (Parking Places) (Amendment No. 1) Order 2009.
2.
  - (1) In this Order the expression “enactment” means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
  - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
  - (3) The Interpretation Act 1978(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Richmond Town) (Parking Places) (Consolidation No. 2) Order 2008(c), as amended, shall have effect as though:-
  - (a) there were added to the items in Schedule 3A to that Order the items numbered 3A/4 and 3A/5 and set out in columns 1, 2, 3, 4 and 5 of the Schedule to this Order; and
  - (b) in Article 30 of that Order:-
    - (i) there were inserted the word “and” following the first occurrence of the words “to that Order”; and
    - (ii) for the words “(Richmond Hill)” there were substituted the words “(Richmond Town)”.

**SCHEDULE**

IN RELATION TO A PARKING PLACE REFERRED TO IN THIS SCHEDULE THE EXPRESSION "PERMITTED HOURS" MEANS THE PERIOD BETWEEN 8.30 AM AND 6.30 PM ON MONDAYS TO SATURDAYS INCLUSIVE, ANY SUCH DAY NOT BEING GOOD FRIDAY, CHRISTMAS DAY OR A BANK HOLIDAY.

PARKING PLACES IN RESPECT OF WHICH THE MAXIMUM PARKING PERIOD FOR WHICH A VEHICLE MAY BE LEFT DURING THE PERMITTED HOURS IS TWO HOURS IF IT DISPLAYS A VALID TICKET FROM A TICKET PARKING METER, OR IN WHICH A VEHICLE MAY BE LEFT BETWEEN 8.30 AM AND 9.30 AM AND BETWEEN 5.30 PM AND 6.30 PM IF IT DISPLAYS A VALID RESIDENTS' OR RESIDENTS' VISITORS PERMIT.

**EXPLANATORY NOTE**

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order introduces new parking places in Sheen Road and Worple Road, Richmond, within the Richmond Town controlled parking zone (Zone "A1"). The parking places may be used to leave vehicles for a maximum period of 2 hours during the permitted hours on payment of a parking charge (pay and display parking), or, if they display a residents parking permit valid for the A1 zone, for the first hour and the last hour of the permitted hours.

The hours of control are on Mondays to Saturdays, between 8.30am and 6.30pm.

The opportunity has been taken to make two typographical corrections to the wording of the most recent consolidation order for the Richmond Town controlled parking zone.

**STATEMENT OF REASONS**

The Council has carried out a review of the parking provision in a part of Sheen Road, Richmond and has concluded that two additional parking places may be introduced without compromising road safety. Additional parking places will be of benefit to persons with a need for short stay parking in the Richmond town centre, and will allow residents with a parking permit to use these bays at the start and end of each day when controls are in force.

1. The Council of the London Borough of Richmond upon Thames proposes to make the above Orders under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the **Richmond Town Parking Places** will be to:-
  - (a) introduce 3 "pay and display" parking bays in Sheen Road between its junctions with Alton Road and Sheen Park; and
  - (b) introduce 2 "pay and display" parking bays in Worple Way near its junction with Sheen Road.
3. Vehicles may be parked in the bays specified in paragraph 2 above on Mondays to Saturdays between 8.30am and 6.30pm for a maximum stay of 2 hours if they display a valid ticket from a ticket machine, or between 8.30am-9.30am and between 5.30pm-6.30pm if they display a valid residents parking permit.
4. The general effect of the **Waiting and Loading Restriction Order** will be to introduce waiting restrictions "no waiting any time" :-
  - (a) on both sides of Sheen Road from its junction with Church Road to a point beyond its junction with Alton Road; and
  - (b) in the side roads of Dunstable Road, Alton Road and Worple Way for distances of up to 6 metres.
5. On the north side of Sheen Road, outside Nos 92-94 Sheen Road, a section of single yellow line ("no waiting, Monday to Saturday, 8.30am-6.30pm") will be retained, having a length of 12.5 metres.
6. The Council is also proposing changes to the bus stop clearway outside Nos 80-90 Sheen Road, notice of which is given separately.
7. Copies of the proposed Orders, plans showing the location and effect of the proposals and the Council's Statement of Reasons for proposing to make the Orders can be inspected, quoting Reference 91/08, at:
  - (a) Richmond Reference Library, Old Town Hall, Whittaker Avenue, Richmond TW9 1TP during opening hours, and
  - (b) the Civic Centre Reception, 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays.
8. Persons wishing to object to or support the proposals or any part thereof should write to the Manager for Highways and Transport, Civic Centre, 44 York Street, Twickenham TW1 3BZ within 21 days of the date of this Notice giving the grounds of their objection.

1. The Council of the London Borough of Richmond upon Thames on 13 March 2009 made the above Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended.
2. The general effect of the **Richmond Town Parking Places** will be to:-
  - (a) introduce 3 "pay and display" parking bays in Sheen Road between its junctions with Alton Road and Sheen Park; and
  - (b) introduce 2 "pay and display" parking bays in Worple Way near its junction with Sheen Road.
3. Vehicles may be parked in the bays specified in paragraph 2 above on Mondays to Saturdays between 8.30am and 6.30pm for a maximum stay of 2 hours if they display a valid ticket from a ticket machine, or between 8.30am-9.30am and between 5.30pm-6.30pm if they display a valid residents parking permit.
4. The general effect of the **Waiting and Loading Restriction Order** will be to introduce waiting restrictions "no waiting any time" :-
  - (a) on both sides of Sheen Road from its junction with Church Road to a point beyond its junction with Alton Road; and
  - (b) in the side roads of Dunstable Road, Alton Road and Worple Way for distances of up to 6 metres.
5. On the north side of Sheen Road, outside Nos 92-94 Sheen Road, a section of single yellow line ("no waiting, Monday to Saturday, 8.00am-6.30pm") will be retained, having a length of 12.5 metres.
6. Copies of the Orders, which will come into operation on 16 March 2009, plans showing the location and effect of the Orders and the Council's Statement of Reasons for making the Orders can be inspected for a period of six weeks from the date of this Notice, quoting Reference 13/09, at:-
  - (a) Richmond Reference Library, Old Town Hall, Whittaker Avenue, Richmond TW9 1TP during opening hours, and
  - (b) the Civic Centre Reception, 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays.
7. Copies of the Orders may be purchased from the Environment Directorate, Civic Centre, 44 York Street, Twickenham TW1 3BZ.
8. Persons wishing to question the validity of the Orders or any of their provisions on the grounds that they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Orders were made, apply for the purpose to the High Court.
