PARKING PLACES ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (CENTRAL TWICKENHAM) (PARKING PLACES) (AMENDMENT No. 10) ORDER 2011

Made: 14 March 2011

Coming into operation: 21 March 2011

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(**a**), as amended, and all other enabling powers hereby make the following Order—

- 1. This Order shall come into operation on 21 March 2011 and may be cited as the London Borough of Richmond upon Thames (Central Twickenham) (Parking Places) (Amendment No. 10) Order 2011.
- 2. (1) In this Order the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Central Twickenham) (Parking Places) Order 2003(c), as amended, shall have effect as though:-
 - (a) for the item numbered 11/2 in Schedule 11 to that Order there were substituted the item similarly numbered and as set out in columns 1, 2, 3, 4 and 5 of Schedule 1 to this Order; and
 - (b) there were revoked from Schedule 11 to that Order the item numbered 11/3 and as set out in columns 1, 2, 3, 4 and 5 of Schedule 2 to this Order.

PARKING PLACES IN WHICH A VEHICLE MAY BE LEFT DURING THE PERMITTED HOURS IF IT DISPLAYS A VALID RESIDENTS', RESIDENTS' VISITORS, BUSINESS OR OPERATIONAL PERMIT.

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

The Council is intending to revoke an existing motor cycle parking bay in Mary's Terrace, Twickenham.

This Order extends two permit holder parking bays in Mary's Terrace, Twickenham, currently located on either side of that bay, such that they occupy the space of the motor cycle bay and become merged into a single bay.

This order, therefore, changes the description of one of those bays to describe the full length of the merged bays, and revokes the description of the other.

- 3. The general effect of the **Central Twickenham Parking Places Amendment Order** is to extend the existing permit holders only parking bay on the south side of Mary's Terrace such that the area of the motor cycle parking bay is included within the length of the permit holders bay.
- 4. Copies of the Orders, which will come into operation on 21 March 2011, a plan showing the location and effect of the Orders and the Council's Statement of Reasons for proposing to make the Orders:-
 - (a) can be inspected for a period of six weeks from the date of this Notice, quoting Reference 21/11, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and

Persons wishing to question the validity of the Orders or any of their provisions on the grounds that they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Orders were made, apply for the purpose to the High Court.
