THE LONDON BOROUGH OF RICHMOND UPON THAMES (CENTRAL TWICKENHAM) (PARKING PLACES) (AMENDMENT No. 6) ORDER 2008

Made: 25 February 2008

Coming into operation: 10 March 2008

The Council of the London Borough of Richmond upon Thames, having consulted with the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), as amended by the Local Government Act 1985(b), the Road Traffic Regulation (Parking) Act 1986(c), the Parking Act 1989(d), and the Road Traffic Act 1991(e) and all other enabling powers hereby make the following Order —

- 1. This Order shall come into operation on 10 March 2008 and may be cited as the London Borough of Richmond upon Thames (Central Twickenham) (Parking Places) (Amendment No. 6) Order 2008.
- 2. (1) In this Order the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, reenacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978(f) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order,
 - (a) the London Borough of Richmond upon Thames (Central Twickenham) (Parking Places) Order 2003(g), as amended, shall have effect as though:-
 - (i) for the parking place numbered 2A/12 in Schedule 2A to that Order there were substituted the parking places similarly numbered and set out in columns 1, 2, 3, 4 and 5 of Schedule 1 to this Order;
 - (ii) for the parking places numbered 10A/16 and 10A/55 in Schedule 4 to that Order there were substituted the parking places similarly numbered and set out in columns 1, 2, 3, 4 and 5 of Schedule 2 to this Order;

- (b) the parking place numbered 3A/1 in Schedule 3A to that Order and the parking place numbered 14/1 in Schedule 14 to that Order are hereby revoked.

(This note is not part of the Order but is intended to indicate its general purport)

This Order:-

- (a) shortens by a distance of 8 metres an existing parking place in Clifden Road which is located at a vehicular crossover by No 44 Clifden Road;
- (b) redesignates a parking place in Grosvenor Road from being one which is reserved for "sole use for business permit holders on Monday-Friday 8.30am – 6.30pm and shared use residents or inner-area business permit holders on Saturday, 8.30am – 6.30pm" to one which is reserved for "shared use, resident or inner area business permit holders on Monday-Saturday, 8.30am – 6.30pm";
- (c) redesignates 3 parking bays in Lion Road from being controlled by parking meter (max stay of 2 hours) to a parking place for use by vehicles which display a residents or "inner area" business parking permit;
- (d) redesignates a parking place in Lion Road from being one for use by vehicles which display an "inner area" business permit (space for 2 vehicles) to 2 parking bays controlled by parking meter (2 hours maximum stay);
- (e) redesignates 2 parking bays in Lion Road from being controlled by parking meter (max stay of 4 hours) to a parking place for use by vehicles which display a residents parking permit (space for 2 vehicles).

SCHEDULE 1 Proposed changes to waiting restrictions

Arlington Road, Twickenham:

In the vicinity of Nos 28-32 Arlington Road, "Sefton Lodge", the entrance to Arlington Works and the triangular island site at this location:-

Change existing waiting restriction "no waiting, Monday to Friday, 10am-4.30pm" to "no waiting at any time."

Atherley Way, Whitton:

On the south-east side, (adjacent to No 33 Heathside and No 14 Atherley Way):-Extend the existing waiting restriction "no waiting at any time" such that it extends for whole of this side of Atherley Way.

The Byeway and St Leonards Road, Sheen:

- (a) at the junction of these two streets; and
- (b) on the corner of The Byeway opposite Nos 1-2 The Byeway and adjacent to the rear garden of No 132 St Leonards Road:-

Introduce the waiting restriction "no waiting at any time"; and

(c) adjacent to the rear garden of No 132 St Leonards Road – allow footway parking (two wheels on the footway) for a distance of 54 metres.

Clifden Road, Twickenham:

Outside No 44 Clifden Road:-

At the turning head by Nos 1-7 and Nos 2-8 Fortescue Avenue:-

Introduce the waiting restriction "no waiting at any time" in the turning head, (other than at the disabled persons parking bay); and allow footway parking (two wheels on the footway) outside No 8 Fortescue Avenue.

Lichfield Road. Kew:

At the junction of Lichfield Road with the cul-de-sac section at the rear of "Royston Court", outside Nos 9 – 15 Lichfield Road and outside Nos 22- 24 Lichfield Road:-

Change the restriction "no waiting Monday – Friday, 10am to 12 noon" to "no waiting at any time".

Reynolds Place and Cambrian Road, Richmond:

At the junction of these two streets, including 15 metres outside Nos 1-4 Reynolds Place:-

Extend the existing and introduce new waiting restrictions "no waiting at any time."

Ship Lane, Mortlake:

On the west side, for 5 metres on each side of the entrance to a private car park approximately 25 metres south of Ship Lane Passage:-

Introduce the waiting restriction "no waiting at any time."

Wiggins Lane and Woodville Road, Ham:

At the junction of these two streets, and on both sides of Wiggins Lane southwards to its junction with Ham Street near Nos 83-105 Ham Street:Introduce the waiting restriction "no waiting at any time."

SCHEDULE 2

Proposed changes to parking provision [Controlled Parking Zone indicated in square brackets]

Arlington Road, Twickenham [East Twickenham]:

In the vicinity of "Sefton Lodge" and the entrance to Arlington Works:-Relocate existing parking places such that they are partly on the footway.

Clifden Road, Twickenham [Central Twickenham]:

Outside No 44 Clifden Road:-

Shorten by 8 metres the parking place for residents' permit holders.

Ellerker Gardens, Richmond [Richmond Town]:

Arlington Road, Twickenham:

In the vicinity of Nos 28-32 Arlington Road, "Sefton Lodge", the entrance to Arlington Works and the triangular island site at this location:-

Change existing waiting restriction "no waiting, Monday to Friday, 10am-4.30pm" to "no waiting on Mondays to Fridays between 7am and 7pm and on Saturdays between 7am and 1pm."

Atherley Way, Whitton:

On the south-east side, (adjacent to No 33 Heathside and No 14 Atherley Way):-Extend the existing waiting restriction "no waiting at any time" such that it extends for whole of this side of Atherley Way.

Clifden Road, Twickenham:

Introduce the waiting restriction "no waiting at any time."

Wiggins Lane and Woodville Road, Ham:

Introduce the waiting restriction "no waiting at any time" in:-

- (a) Woodville Road both sides, for a distance of 10 metres from Wiggins Lane;
- (b) Wiggins Lane (the south-west and south-east sides, i.e. the outside of the bend between Ham Street and Woodville Road near Nos 83-105 Ham Street) the whole length between Woodville Road and Ham Street;
- (c) Wiggins Lane (the north-east and north-west sides, i.e. the inside of the bend as above) from Ham Street to and including the entrance to the garages at the rear of Nos 83-105 Ham Street.

Ellerker Gardens, Richmond [Richmond Town]:

Extend the adjacent residents' permit parking place by 6 metres to take the place of one of the two existing Doctor's parking bays near Onslow Gardens, which is to be discontinued.

Gainsborough Road, Kew [South Kew]:

Outside No 92 Gainsborough Road:-

Introduce a new residents' permit only parking place to operate Mondays to Fridays, 10am to 12 noon (and discontinue other parking bays in this vicinity which were inadvertently introduced on private land).

Grosvenor Road, Twickenham [Central Twickenham]:

The south-west side, near Station Yard:-

Change an existing parking place from a shared use bay (business permit only on Monday to Friday and residents' or business permit on Saturday) to a shared use bay (residents' or business permit holders, Mondays to Saturdays).

Halford Road, Richmond [Richmond Town]:

Near No 51 Halford Road and adjacent to No 18 The Vineyard – change 2 existing parking meter bays into a parking place for resident permit holders only.

Lichfield Road, Kew [Kew]:

Introduce gaps ("loading gaps") into the two residents parking places outside Nos 1-23 and Nos 2-24 Lichfield Road such that a single yellow line will be marked at the each vehicle crossing point serving these houses.

Lion Road, Twickenham [Central Twickenham]:

- (a) near No 2 Lion Road and adjacent to No 164 Heath Road change 3 existing parking meter bays into a parking place for resident or business permit holders only;
- (b) outside Nos 11-13 Lion Road change an existing parking place for "inner area" business permit holders only into 2 parking meter bays (maximum stay of 2 hours);
- (c) opposite Nos 56-58 Lion Road change 2 existing parking meter bays into a parking place for resident permit holders only.

Upper Grotto Road, Twickenham [South Twickenham]:

Adjacent to the flank wall of No 29 Pope's Grove:-

Merge two existing parking bays (space for one vehicle each) for residents' permit only into a single parking place with space for 3 vehicles.

SCHEDULE 3 Changes to doctors parking provision

Ellerker Gardens, Richmond [within the Richmond Town controlled parking zone]:

- (a) discontinue one of the two existing Doctor's parking bays near Onslow Gardens, and extend the adjacent residents' permit parking place to include that bay; and
- (b) change the hours of operation of the remaining Doctor's parking bay from "Mondays to Saturdays, 8.30am-6.30pm" to "Mondays to Fridays, 7.30am-6.30pm and Saturdays 7.30am-1.00pm."

SCHEDULE 4

Proposals in respect of which the Council had deferred a decision

Changes to waiting restrictions and parking provision

The Byeway and St Leonards Road, Sheen:

- (a) introduce waiting restrictions "no waiting at any time":-
 - (i) at the junction of these two streets; and
 - (ii) on the corner of The Byeway opposite Nos 1-2 The Byeway and adjacent to the rear garden of No 132 St Leonards Road; and
- (b) allow footway parking (two wheels on the footway) in The Byeway for a distance of 54 metres adjacent to the rear garden of No 132 St Leonards Road.

Changes to parking provision

Halford Road, Richmond (in the Richmond Town Controlled Parking Zone): outside No 27 Halford Road – extend an existing parking place (resident permit holders only) by 5 metres.
