### PARKING PLACES ORDER

# THE LONDON BOROUGH OF RICHMOND UPON THAMES (CENTRAL TWICKENHAM) (PARKING PLACES) (AMENDMENT No 1) ORDER 2004

Made: 6<sup>th</sup> December 2004

Coming into operation: 13<sup>th</sup> December 2004

The Council of the London Borough of Richmond upon Thames, having consulted with the Commissioner of Police for the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), as amended, and the Road Traffic Act 1991(b) and all other enabling powers hereby make the following Order:-

- 1. This Order shall come into operation on 13<sup>th</sup> December 2004 and may be cited as The London Borough of Richmond upon Thames (Central Twickenham) (Parking Places) (Amendment No 1) Order 2004.
- 2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The London Borough of Richmond upon Thames (Central Twickenham) (Parking Places) Order 2003(c) shall have effect as though for the parking place numbered 11/7 in Schedule 11 to that Order there were substituted the parking place similarly numbered and set out in columns 1, 2, 3, 4 and 5 of the Schedule to this Order.

## SCHEDULE (See Article 2)

IN RELATION TO A PARKING PLACE REFERRED TO IN THIS SCHEDULE THE EXPRESSION "PERMITTED HOURS" MEANS THE PERIOD BETWEEN 8.30AM AND 6.30PM ON MONDAYS TO SATURDAYS INCLUSIVE, ANY SUCH DAY NOT BEING CHRISTMAS DAY, GOOD FRIDAY OR A BANK HOLIDAY.

PARKING PLACES IN WHICH A VEHICLE MAY BE LEFT DURING THE PERMITTED HOURS IF IT DISPLAYS A VALID RESIDENTS', RESIDENTS' VISITORS, BUSINESS OR OPERATIONAL PERMIT.

### RELATING TO RICHMOND ROAD, TWICKENHAM

- The Council of the London Borough of Richmond upon Thames propose to make the above Orders under sections 6, 45, 46, 49, 51 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (as amended) and the Road Traffic Act 1991.
- 2. The general effect of the Bus Stop Clearway Order will be to:-
  - (a) remove the existing east-bound bus stop clearway on the north-west side of Richmond Road outside Nos. 155 161 Richmond Road; and
  - (b) introduce a replacement bus stop clearway on the same side of Richmond Road outside "Leeson House", Richmond Road (south-west of its junction with Marble Hill Gardens) operating "at any time".
- 3. The general effect of the Central Twickenham Parking Places Order will be to remove a residents and business permit holders parking place on the north-west side of Richmond Road outside "Leeson House", Richmond Road (operating between 8.30am and 6.30pm on Mondays to Saturdays).
- 4. The general effect of the St Margaret's South Parking Places Order will be to shorten a residents permit holders parking place on the north-west side of Richmond Road (operating between 10.00am and 4.30pm on Mondays to Fridays) by a length of 5 metres.
- 5. The general effect of the Waiting and Loading Restriction Order will be to alter the waiting restrictions "no waiting between 8.30am and 6.30pm on Mondays to Saturdays inclusive" to "no waiting at any time" on the north-west side of Richmond Road from outside "Westbourne House", Richmond Road to outside No 135 Richmond Road.
- 6. Copies of the Draft Orders, a plan showing the location and effect of the proposals and the Council's Statement of Reasons for proposing to make the Orders can be inspected for a period of 21 days from the date of this Notice at:
  - (a) Twickenham Library, Garfield Road, Twickenham TW1 3JT during opening hours, and
  - (b) the Civic Centre (Second Floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays.

7. Persons wishing to object to or support the proposals or any part thereof should write to the Transport Planning Manager, Civic Centre, 44 York Street, Twickenham TW1 3BZ within 21 days of the date of this Notice giving the grounds of their objection.

  - (b) shorten a residents permit holders parking place on the north-west side of Richmond Road (operating between 10.00am and 4.30pm on Mondays to Fridays) by a length of 5 metres;
  - (c) alter the waiting restrictions "no waiting between 8.30am and 6.30pm on Mondays to Saturdays inclusive" to "no waiting at any time" on the north-west side of Richmond Road from outside "Westbourne House", Richmond Road to outside No 135 Richmond Road.
- 3. Copies of the Orders, which will come into operation on 13<sup>th</sup> December 2004, a plan showing the location and effect of the Orders and the Council's Statement of Reasons for making the Orders can be inspected for a period of 6 weeks from the date of this Notice at: -
  - (a) Twickenham Library, Garfield Road, Twickenham TW1 3JT during opening hours, and
  - (b) the Civic Centre (Second Floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays.
- 4. Copies of the Orders may be purchased from the Environment Planning and Review Section, Civic Centre, 44 York Street, Twickenham TW1 3BZ.
- 5. Persons wishing to question the validity of any of the Orders or any of their provisions on the grounds that they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Orders were made, apply for the purpose to the High Court.
