THE LONDON BOROUGH OF RICHMOND UPON THAMES (SOUTH TWICKENHAM) (PARKING PLACES) (AMENDMENT No. 4) ORDER 2010

Made: 19 October 2010

Coming into operation: 25 October 2010

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended, and all other enabling powers hereby make the following Order—

- 1. This Order shall come into operation on 25 October 2010 and may be cited as the London Borough of Richmond upon Thames (South Twickenham) (Parking Places) (Amendment No. 4) Order 2010.
- 2. (1) In this Order the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978**(b)** shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (South Twickenham) (Parking Places) Order 1994(c), as amended, shall have effect as though:-
 - (a) the items numbered 1/1 to 1/11 inclusive in Schedule 1 to that Order were revoked;
 - (b) the items numbered 2/7, 2/38 to 2/48 inclusive in Schedule 2 to that Order were revoked:
 - (c) for the items in Schedule 2 to that order numbered 2/1, 2/3, 2/9, 2/11, 2/12, 2/13, 2/14, 2/15, 2/16, 2/18, 2/20, 2/21, 2/22, 2/23, 2/24, 2/25, 2/26, 2/28, 2/29, 2/30, 2/32 and 2/35 there were substituted the items similarly numbered and as set out in columns 1, 2, 3, 4 and 5 of Schedule 1 to this Order;

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

The Council has previously made three orders which have brought into operation some of the proposals of which notice was given on 27 November 2009. The Council is now making three more orders which bring into force the remainder of those proposals.

The orders previously made are:-

- the London Borough of Richmond upon Thames (South Twickenham) (Parking Places) (Amendment No. 3) Order 2010 [TMO 2010/19];
- the London Borough of Richmond upon Thames (Parking Places) (Supplementary Provisions, Permits) (Amendment No. 1) Order 2010 [TMO 2010/20]; and
- the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Amendment No. 36) Order 2010 [TMO 2010/21].

This Order provides additional permit holder parking provision in Tower Road and streets to the north thereof which were not included in the previous parking places amendment order. This has been achieved by:-

- redesignating two free limited-time parking bays in Radnor Road as permit holder only bays (items 2/22 and 2/23A) and compensating by providing additional free limited time bays in Tower Road;
- (b) revoking an existing permit holder only bay in Hollies Close (item 2/7), but compensating by providing a longer permit holder only bay on the opposite side of the street (item 2/9);
- (c) extending some existing permit holder only bays or providing new permit holder bays where no parking provision had previously existed as follows:-
 - (i) Abbottsmede Close, the west side (item 2/1);
 - (ii) Bonser Road, the north side (item 2/3);
 - (iii) Holmes Road, the south side (item 2/11);
 - (iv) Orford Gardens, the west side (item 2/12);
 - (v) Popes Grove, the north side (items 2/13, 2/15 and 2/18):
 - (vi) Popes Grove, the south side (items 2/14, 2/16, 2/20, 2/21 and 2/21A);
 - (vii) Radnor Road, the east side (items 2/22, 2/23 and 2/23A);
 - (viii) Radnor Road, the west side (items 2/24 and 2/25);
 - (ix) River View Gardens, the north side (item 2/26);
 - (x) Tower Road, the north side (items 2/28, 2/29, 2/29A, 2/30 and 2/32); and
 - (xi) Upper Grotto Road, the west side (item 2/35).

This order also revokes the remaining free limited-time parking places within the South Twickenham controlled parking zone.

Separate orders make provision for:-

- (a) the free limited-time parking bays within the South Twickenham CPZ (the order to be made under section 6 of the Road Traffic Regulation Act 1984); and
- (b) the local changes to the waiting restrictions in Tower Road and streets to the north thereof.

SOUTH TWICKENHAM CONTROLLED PARKING ZONE

(Reference 78/10)

- 1. The Council of the London Borough of Richmond upon Thames on 19 October 2010 made the above Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended.
- 2. On 19 March 2010 the Council gave notice that it had made three orders (as specified in Schedule 4 to this notice) which introduced, in part, some of the proposals in respect of the South Twickenham Controlled Parking Zone which had been advertised on 27 November 2009 and that it had deferred making a decision on the remaining proposals. The Council is hereby giving notice that the further orders as stated at the head of this notice give effect to a decision to introduce the remaining parts of the original proposals.
- 3. The general effect of the **South Twickenham Parking Places Amendment Order** is to make some minor changes (additions to, alterations to and the removal of) the existing permit holder parking bays in certain streets of the zone as indicated in Schedule 1 to this notice.
- 4. The hours of control of this zone, which apply to the whole of the zone other than in the southern part of Waldegrave Gardens, are Mondays to Fridays inclusive between 8.30am and 10.30am.
- 5. This order has no effect on the charges for residents' parking permits or residents' visitor's parking permits for this zone (but please see paragraph 12).
- 6. The general effect of the **Free Parking Places Limited Time Amendment Order** is to make changes to the existing free limited time parking bays within the area of the South Twickenham controlled parking zone. Certain bays will be shortened, extended or revoked, and one new bay is introduced, all as specified in Schedule 2 to this notice. Any existing bays not listed in that schedule will remain in place without alteration. Free parking bays in this zone allow a maximum stay of 1 hour, and operate for the times specified in paragraph 4 above.
- 7. The general effect of the **Waiting and Loading Restriction Amendment Order** is to make some minor changes to waiting restrictions in other streets within the zone as specified in Schedule 3 to this notice.
- 8. The Council is giving separate notice with regard to new proposals to exclude part of Abbottsmede Close from the South Twickenham zone and to make minor changes to parking provision and waiting restrictions in Popes Grove.

- 9. Copies of the Orders, which will come into operation on 25 October 2010, a plan showing the location and effect of the Order and the Council's Statement of Reasons for proposing to make the Orders:-
 - (a) can be inspected for a period of six weeks from the date of this Notice, quoting Reference 78/10, at:-
 - Twickenham Library, Garfield Road, Twickenham, Middlesex TW1 3JT during opening hours, and
 - the Civic Centre (Planning Reception, ground floor), 44 York Street,
 Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; or
 - (b) may be viewed on the Council's web-site at http://www.richmond.gov.uk/traffic_management_orders.htm
- 10. Copies of the Orders may be purchased from the Environment Directorate, Civic Centre, 44 York Street, Twickenham TW1 3BZ.
- 11. Persons wishing to question the validity of the Orders or any of their provisions on the grounds that they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Orders were made, apply for the purpose to the High Court.
- 12. Readers should note that, on 8 October 2010, the Council gave notice of proposed variations to permit and other parking charges. The consultation period in respect of those proposals will end on 29 October. If and when such variations are introduced, they will have effect in all parking zones throughout the borough.

- 1. The Council of the London Borough of Richmond upon Thames propose to make the above Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the **South Twickenham Parking Places Amendment Order** will be to:-
 - (i) vary the hours of control of the South Twickenham controlled parking zone which applies to that part of Waldegrave Gardens as lies between its junctions with Waldegrave Road and Tower Road, such that they will have effect on Mondays to Fridays inclusive between 10.30am and 2.30pm; and
 - (ii) make some minor changes to the existing permit holder only bays in the remaining streets of the zone as indicated in Schedule 1 to this notice.
- 3. The current hours of control of this zone, which will remain in force for the whole of the zone other than as specified above, apply on Mondays to Fridays inclusive between 8.30am and 10.30am.
- 4. This proposal will have no effect on the charges for residents' parking permits or residents' visitor's parking permits for this zone.
- 5. The general effect of the **Supplementary Provisions, Permits Amendment Order** will be to vary the hours when residents' visitor's parking permits are valid, when used in the South Twickenham CPZ, such that one residents' visitor's permit will be valid for the aggregate 6-hour period of the existing hours of operation specified in paragraph 3 and the varied hours of operation specified in paragraph 2(i).
- 6. The general effect of the **Free Parking Places Amendment Order** will make changes to the existing provision for free limited time parking bays within the area of the South Twickenham controlled parking zone. Certain bays will be shortened, extended or revoked, and one new bay is proposed. Free parking bays in this zone allow a maximum stay of 1 hour, and operate for the times specified in paragraph 3 above. Further particulars are given in Schedule 2 to this notice. Any existing bays not listed in that schedule will remain in place without alteration.
- 7. The general effect of the **Waiting and Loading Restriction Amendment Order** will be to:-

- (i) change the operational hours of the single yellow lines which are marked in the length of Waldegrave Gardens specified in paragraph 2(i) to the hours specified in that paragraph; and
- (ii) make some minor changes to waiting restrictions in other streets within the zone as specified in Schedule 3 to this notice.
