# THE LONDON BOROUGH OF RICHMOND UPON THAMES (EAST SHEEN) (PARKING PLACES) (AMENDMENT No 4) ORDER 2012

Made: 9 January 2012

Coming into operation: 16 January 2012

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46 and 49 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(**a**), as amended, and all other enabling powers hereby make the following Order —

- 1. This Order shall come into operation on 16 January 2012 and may be cited as the London Borough of Richmond upon Thames (East Sheen) (Parking Places) (Amendment No. 4) Order 2011.
- 2. (1) In this Order the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
  - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
  - (3) The Interpretation Act 1978(**b**) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (East Sheen) (Parking Places) Order 2001(c), as amended, shall have effect as though:-
  - (a) there were added to the table in Article 10 to that order particulars as to the payment method, parking charge, parking period and maximum parking period in respect of parking places designated by Schedule 1A to that Order as follows:-

#### EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order varies the designation of a number of existing parking places in Milton Road, Portman Avenue, Thornton Road and Vernon Road such that they become shared-use bays for use by pay and display or voucher parking, with a maximum stay of 2 hours, or residents or business parking permits.

The opportunity has been taken to correct a typographical error in the description of item 5/38, a resident permit holder bay in Vernon Road.

The bays affected (where the maximum stay for pay and display or voucher parking is 2 hours) are hereby designated in a new schedule (schedule 1A). For the sake of completeness, a table has been included in this order to specify the basic pay and display and voucher parking charges in respect of this schedule. The charges specified here are subject to the general variation of parking charges as provided for by the London Borough of Richmond upon Thames (On-Street Parking Places) (Parking Charges) Order 2011, which sets out the scheme for discounted charges for residents when using a RichmondCard and other associated matters.

# SHARED-USE PARKING BAYS IN EAST SHEEN CONTROLLED PARKING ZONE (Reference 01/12)

- 1. The Council of the London Borough of Richmond upon Thames on 9 January 2012 made the above Orders under sections 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the **Car Club Parking Places Amendment Order** is to discontinue 16 parking bays for car club vehicles (listed in Schedules 1 and 2) on the grounds that the use of the car club vehicles is insufficient to justify their continued use.
- 3. The bays listed in Schedule 1 are within various controlled parking zones as noted. Any bays withdrawn will revert to their previous designation as resident permit-holder or permit-holder only parking bays within that CPZ and these are shown in Schedule 1. At the bays listed in Schedule 2, there will be no parking restrictions if the bays are withdrawn.
- 4. The general effect of the **East Sheen Parking Places Amendment Order** is to make permanent the changes to some of the shared-use parking bays in the East Sheen controlled parking zone (as specified in Schedule 3 to this notice) which, in December 2009, were altered as an experimental scheme to restrict the maximum period for pay and display or voucher parking to 2 hours.
- 5. Copies of the Orders, which will come into operation on 16 January 2012, plans showing the location and effect of the Orders and the Council's Statement of Reasons for proposing to make the Orders:-
  - (a) can be inspected for a period of six weeks from the date of this Notice, quoting Reference 59/11, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and

#### STATEMENT OF REASONS FOR PROPOSING TO MAKE THIS ORDER

The Council of the London Borough of Richmond upon Thames is intending to revoke 16 designated parking spaces currently reserved for car club vehicles. These spaces are located in various streets throughout the borough.

The level of usage of the car club vehicles which are normally parked in these bays is insufficient to justify the continued designation of these spaces as being reserved for these vehicles, and better use will be made if the spaces revert to their previous status, which is either as designated bays within a controlled parking zone or to an unrestricted use.

#### STATEMENT OF REASONS FOR PROPOSING TO MAKE THIS ORDER

The Council of the London Borough of Richmond upon Thames is intending to continue in force indefinitely a change to some shared-use parking bays within the East Sheen controlled parking zone.

The shared-use bays are for the use of residents or business users who have a valid parking permit or for any other driver who pays for parking either by means of a pay-and-display ticket machine or pay-by phone or who displays a parking voucher. The alteration is to reduce the maximum period for which a pay and display ticket or parking voucher is valid or the maximum period of stay if payment is made using the telephone payment parking scheme from 4 hours to 2 hours, within the hours of operation of this CPZ. The reduction in the maximum stay provides a faster turn-over of parked vehicles than had been the case previously.

The change in respect of the maximum stay was first introduced as an experimental scheme in December 2009. The Council now intends that the change should be continued on a permanent basis.

The bays are located in Milton Road, Portman Avenue, Thornton Road and Vernon Road, Sheen.
