## PARKING PLACES ORDER

### THE LONDON BOROUGH OF RICHMOND UPON THAMES (EAST SHEEN) (PARKING PLACES) (AMENDMENT No. 1) ORDER 2003

Made 27 January 2003

Coming into operation: 3 February 2003

The Council of the London Borough of Richmond upon Thames, having consulted with the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49, 51 and 124 of and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (a) as amended by the Local Government Act 1985 (b), the Road Traffic Regulation (Parking) Act 1986 (c), the Parking Act 1989 (d) and the Road Traffic Act 1991 (e) and all other enabling powers hereby make the following Order:-

1. This Order shall come into operation on 3 February 2003 and may be cited as The London Borough of Richmond upon Thames (East Sheen) (Parking Places) (Amendment No. 1) Order 2003.
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order, The London Borough of Richmond upon Thames (East Sheen) (Parking Places) Order 2001 (f) shall have effect as though:-
  - (a) for the items in Schedule 5 to that Order numbered 5/14, 5/24, 5/32 and 5/37 there were substituted the items similarly numbered and set out in columns 1, 2, 3, 4 and 5 of Schedule 1 to this Order;
  - (b) there were added to Schedule 1 to that Order the item numbered 1/6 and set out in columns 1, 2, 3, 4 and 5 of Schedule 2 to this Order;
  - (c) there were added to Schedule 2 to that Order the items numbered 2/3, 2/4, 2/5 and 2/6 and set out in columns 1, 2, 3, 4 and 5 of Schedule 3 to this Order;
  - (d) there were added to Schedule 3 to that Order the items numbered 3/8, 3/9 and 3/10 and set out in columns 1, 2, 3, 4 and 5 of Schedule 4 to this Order;
  - (e) there were added to Schedule 5 to that Order the items numbered 5/39, 5/40, 5/41, 5/42, 5/43, 5/44, 5/45, 5/46, 5/47, 5/48 and 5/49 and set out in columns 1, 2, 3, 4 and 5 of Schedule 5 to this Order; and

### EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport)

This Order:-

- (a) introduces the following designated parking places which make permanent some of the provisions of Experimental TMO 2001/62:-
  - (i) Portman Avenue, east side (see Schedule 5, Item 5/39);
  - (ii) Portman Avenue, west side (see Schedule 5, Item 5/40);
  - (iii) Vernon Road, north side (see Schedule 5, Item 5/41);
  - (iv) Vernon Road, north side (see Schedule 5, Item 5/42);
  - (v) Vernon Road, south side (see Schedule 5, Item 5/43);
  - (vi) Vernon Road, south side (see Schedule 5, Item 5/44);
- (b) makes the following changes to existing designated parking places:-
  - (i) Howgate Road, east side, changes four resident permit holder spaces to shared use spaces for use by residents/business permit holders plus those using parking vouchers or a pay and display machine (see Schedule 1, item 5/14 and Schedule 4, item 3/8);
  - (ii) Oaklands Road, west side, changes six resident permit spaces to shared use spaces for use by residents / business permit holders plus those using parking vouchers or a pay and display machine (see Schedule 1, item 5/24 and Schedule 4, item 3/9);
  - (iii) Thornton Road, east side, changes six resident permit holder spaces to shared use spaces for residents / businesses parking vouchers / pay and display machine (see Schedule 1, item 5/32 and Schedule 4, item 3/10);
  - (iv) Vernon Road, south side, changes one existing resident permit holder space to a pay and display space (see Schedule 1, item 5/37 and Schedule 2 item 1/6);
- (c) introduces the following designated parking places:-
  - (i) St Leonard's Road, south side (see Schedule 1, item 5/28);
  - (ii) Paynesfield Avenue, east side (see Schedule 3 Item 2/3);
  - (iii) Paynesfield Avenue, west side (see Schedule 3 Item 2/4);
  - (iv) Portman Avenue, east side (see Schedule 3 Item 2/5) - *was Item 3/6 in 2001/62;*
  - (v) Portman Avenue, west side (see Schedule 3 Item 2/6) - *was Item 3/7 in 2001/62;*
  - (vi) Alexandra Road, east side (see Schedule 5 Item 5/45);
  - (vii) Alexandra Road, west side (see Schedule 5 Item 5/46);
  - (viii) Paynesfield Avenue, east side (see Schedule 5 Item 5/47);
  - (ix) Paynesfield Avenue, west side (see Schedule 5 Item 5/48);
  - (x) South Worple Way, south side (see Schedule 5 Item 5/49);
- (d) extends the limits of the CPZ to include the following streets or parts of streets within the area for the purpose of the definition of "resident" or "business user" (see Schedule 6):-
  - (i) Alexandra Road;
  - (ii) Paynesfield Avenue;
  - (iii) South Worple Way, from its junction with Church Avenue to a point opposite the common boundary of Nos 56 and 57 South Worple Way.
