### PARKING PLACES ORDER

# THE LONDON BOROUGH OF RICHMOND UPON THAMES (THE ALBERTS) (PARKING PLACES) (AMENDMENT No. 3) ORDER 2007

Made: 8 May 2007

Coming into operation: 21 May 2007

The Council of the London Borough of Richmond upon Thames, having consulted with the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49, 51 and 124 of, and Part III and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended by the Local Government Act 1985(b), the Road Traffic Act 1991(c) and all other enabling powers hereby make the following Order –

- 1. This Order shall come into operation on 21 May 2007 and may be cited as the London Borough of Richmond upon Thames (The Alberts) (Parking Places) (Amendment No. 3) Order 2007.
- (1) In this Order the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
  - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, reenacted by or as having effect by virtue of any subsequent enactment.
  - (3) The Interpretation Act 1978(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (The Alberts) (Parking Places) Order 1994(e) ("the 1994 Order"), as amended, shall have effect as though:-
  - (a) for the parking place numbered 1/17 in Schedule 1 to that Order there were substituted the parking place similarly numbered and set out in columns 1, 2, 3, 4 and 5 of Schedule 1 to this Order; and

- (b) for the parking place numbered 2/26 in Schedule 2 to that Order there were substituted the parking place numbered 2/26A and 2/26B and set out in columns 1, 2, 3, 4 and 5 of Schedule 2 to this Order
- 4. In the previous amendment Order(a) to the 1994 Order which was made on 19 May 2003 and which came into effect on 26 May 2003, all references in that order to its title shall be construed as if the words "Amendment No. 3" had been printed as "Amendment No. 2".

#### **EXPLANATORY NOTE**

(This note is not part of the Order, but is intended to indicate its general purport)

This Order decreases the length of a designated parking place outside Nos. 1 - 12 Peldon Court by a distance of 6 metres, and splits into two parts a designated parking place on the west side of Houblon Road; the two parts being separated by a disabled person's parking place.

This Order is the third amendment to the 1994 Order. Article 4 of this Order corrects an error in the previous amendment order (made in 2003) which indicated that that order was the third amendment and not the second, as was in fact the case.

#### STATEMENT OF REASONS

A parking place is to be introduced into Peldon Court, Sheen Road in which a vehicle displaying a blue badge may wait at any time. This bay is to be located at one end of an existing designated parking place within "The Alberts" controlled parking zone. The designated parking place is to be shortened by a length of 6 metres to allow for the disabled person's parking place.

A parking place is to be introduced into Houblon Road in which a vehicle displaying a blue badge may wait at any time. This bay is to be located within the extents of an existing designated parking place within "The Alberts" controlled parking zone. That designated parking place is to be split into two parts and separated by the length of the disabled person's parking place.

## VARIOUS STREETS THROUGHOUT THE BOROUGH (Reference 22/07)

- 1. The Council of the London Borough of Richmond upon Thames on 8 May 2007 made the above Orders under sections 6, 45, 46, 49, 51 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (as amended) and the Road Traffic Act 1991.
- 2. The principal objective of the Free Parking Places Order is to introduce a number of parking places for disabled persons' vehicles where a high level of parking made reasonable means of access difficult and to discontinue a number of similar parking places previously provided where the demand for such bays no longer exists. Further particulars are given in paragraphs 4, 5 and 6.
- 3. The principal objective of the two Parking Places Orders is to amend the parking provision in The Alberts and the Richmond Town controlled parking zones such that one residents' space is removed from Peldon Court, Sheen Road, Richmond and one residents' space is added to Halford Road, Richmond to accommodate the parking bays described in paragraphs 4 (a) (xxiv) and 4 (b) (vii) respectively.
- 4. The Free Parking Places Order

- 6. Further the notice given on 9 February 2007 in which it was stated that the Council had deferred a decision as to a number of proposals for parking provision and waiting restrictions in the Teddington area for which notice had originally been given on 15 September 2006, the Council has decided to introduce the two parking places for vehicles displaying a disabled person's badge in Station Road, Teddington and Park Road, Teddington (items 4 (a) (xxiii) and (xxvii) above).
