The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49, 51 and 124 of and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (a), as amended, and the Road Traffic Act 1991(b), and all other enabling powers hereby make the following Order:-

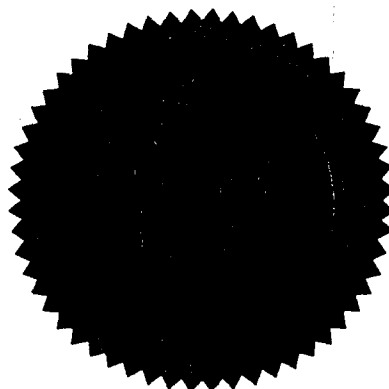
1. This Order shall come into operation on 18th April 1994 and may be cited as the London Borough of Richmond upon Thames (The Alberts)(Parking Places)(Amendment No. 1) Order 1994.
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (The Alberts)(Parking Places) Order 1994 (c) shall have effect as though:
  - (a) there was added to Schedule 1 to that Order the item numbered 1/23 and set out in columns 1, 2, 3, 4, and 5 of Schedule 1 to this Order;
  - (b) there were added to Schedule 2 to that Order the items numbered 2/51 and 2/52 and set out in columns 1, 2, 3, 4 and 5 of Schedule 2 to this Order;
  - (c) there were added to Schedule 3 to that Order the items numbered 19 and 20 and set out in Schedule 3 to this Order.

IN RELATION TO A PARKING PLACE REFERRED TO IN THIS SCHEDULE THE EXPRESSION "PERMITTED HOURS" MEANS THE PERIOD BETWEEN 8.30 A.M. AND 6.30 P.M. ON MONDAYS TO FRIDAYS INCLUSIVE, ANY SUCH DAY NOT BEING CHRISTMAS DAY, GOOD FRIDAY OR A BANK HOLIDAY.

PARKING PLACES IN RESPECT OF WHICH THE MAXIMUM PARKING PERIOD FOR WHICH A VEHICLE MAY BE LEFT DURING THE PERMITTED HOURS IS FOUR HOURS IF IT DISPLAYS A VALID PARKING VOUCHER OR VOUCHERS, OR IN WHICH IT MAY BE LEFT DURING THE PERMITTED HOURS IF IT DISPLAYS A VALID RESIDENTS', RESIDENTS' VISITORS OR OPERATIONAL PERMIT.
