(PARKING PLACES) (AMENDMENT NO. 1) ORDER 2000

Coming into operation 23rd October 2000

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49, 51 and 124 of and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (a), as amended, and the Road Traffic Act 1991 (b) and all other enabling powers hereby make the following Order:-

- 1. This Order shall come into operation on the 23rd October 2000 and may be cited as the London Borough of Richmond upon Thames Twickenham Stadium Event Days (Parking Places) (Amendment No. 1) Order 2000.
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Twickenham Stadium Event Days) (Parking Places) Order 1999 (c), as extended and amended, shall have effect as though:-
  - (a) for the item numbered 3 in Schedule 1 (PART A) to that Order there were substituted the item similarly numbered and set out in columns 1, 2, 3, 4 and 5 of Schedule 1 to this Order;
  - (b) for the item numbered 45 in Schedule 1 (Part H) to that Order there were substituted the item similarly numbered and set out in columns 1, 2, 3, 4 and 5 of Schedule 2 to this Order.

### EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport).

The Order amends the Twickenham Stadium Event Day Controlled Parking Zone to remove the parking for residents and their visitors from the north-east side of Hounslow Road, Whitton between the junctions with Vicarage Road and Kneller Road and designates three new parking places for residents on the south-west side. The Order also shortens a length of residents parking on the eastern side of Burnside Close, Twickenham.

## STATEMENT OF REASONS

The Order is intended to amend the Twickenham Stadium Event Day Controlled Parking Zone to remove and relocate parking places for residents and their visitors in a length of Hounslow Road, Whitton between the junctions with Vicarage Road and Kneller Road to improve road safety and the passage of through traffic, particularly buses.

The Order also shortens a parking place for residents on the east side of Burnside Close, Twickenham to improve access and egress for residents opposite to their off-street parking facilities.
