The Council of The London Borough of Richmond upon Thames, having consulted with the Commissioner of Police for the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49, 51 and 124 of, and Part III and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (a), as amended, and the Road Traffic Act 1991 (b) and all other enabling powers hereby make the following Order:-

- 1. This Order shall come into operation on 28 April 2003 and may be cited as The London Borough of Richmond upon Thames (Hampton Wick) (Parking Places) (Amendment No. 3) Order 2003.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The London Borough of Richmond upon Thames (Hampton Wick) (Parking Places) Order 1994 (c), as amended, shall have effect as though the item numbered 8/4 of Schedule 8 to that Order there were substituted the item similarly numbered and set out in columns 1, 2, 3, 4 and 5 of the Schedule to this Order.
