THE LONDON BOROUGH OF RICHMOND UPON THAMES (HAMPTON WICK)(PARKING PLACES)

(AMENDMENT NO. 1) ORDER 1996

Made 29th April 1996

Coming into operation 7th May 1996

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 45, 46, 49, 51 and 124 of and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (a), as amended, and the Road Traffic Act 1991 (b) and all other enabling powers hereby make the following Order:-

- 1. This Order shall come into operation on 7th May 1996 and may be cited as the London Borough of Richmond upon Thames (Hampton Wick)(Parking Places) (Amendment No. 1) Order 1996.
- 2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Hampton Wick)(Parking Places) Order 1994 (c) shall have effect as though:
 - (a) there was included in Schedule 3 to that Order the item numbered 3/2 and set out in columns 1, 2, 3, 4 and 5 of Schedule 1 to this Order;
 - (b) for the items numbered 7/21 and 7/31 of Schedule 7 to that Order there were substituted the items similarly numbered and set out in columns 1, 2, 3, 4 and 5 of Schedule 2 to this Order;
 - (c) there was included in Schedule 7 to that Order the item numbered 7/48 and set out in columns 1, 2, 3, 4 and 5 and of Schedule 2 to this Order;
 - (d) there was included in Schedule 9 to that Order the item numbered 9/4 and set out in columns 1, 2, 3, 4 and 5 of Schedule 3 to this Order;
 - (e) the items numbered 1/1, 1/2, 1/3, 5/1, 6/1, 7/34, 7/35, 8/5, 8/6 and 10/1 of Schedules 1, 5, 6, 7, 8 and 10 respectively to that Order are hereby revoked;
 - (f) these were included as Schedule 12, Schedule 13 and Schedule 14 to that Order Schedule 4, Schedule 5 and Schedule 6 respectively to this Order;

- (g) in the headings-to Schedule 1 to that Order after the words "one hour", to Schedule 2 Part I and Part II after the words "two hours", to Schedule 3 after the words "four hours", to Schedule 4 after the words "parking meter", to Schedule 5 after the words "ten hours" and to Schedule 6 after the words "parking meter" there were added the words "or in which a vehicle may be left between 8.30 am and 9.30 am and between 5.30 pm and 6.30 pm if it displays a valid residents' or residents' visitors permit";
- (h) there was included as paragraph (8)(d) of Article 15 of that Order the following paragraph:

"a vehicle displaying a residents' permit in accordance with the provisions of Article 7 of this Order may be left in a parking bay in any parking place referred to in Schedule 1, Schedule 2 Part I, Schedule 2 Part II, Schedule 3, Schedule 4, Schedule 5, Schedule 6 or Schedule 12 from 8.30 am until 9.30 am and from 5.30 pm until 6.30 pm provided that the use of the parking bay in which the vehicle is left has not been suspended:

Provided that in connection with the use of such a parking permit the charge has been paid for the period during which the vehicle is left in the parking bay, and such a charge has been indicated as having been paid in accordance with the provisions of Article 38 of this Order";

(i) in the Arrangement of Articles of that Order for the words "Schedule 7, 8, 9 or 10" there were substituted the words "Schedule 7, 8, 9, 10, 13 or 14", for the words "Schedule 1, 2, 3, 4, 5, 6 or 10" there were substituted the words "Schedule 1, 2, 3, 4, 5, 6, 10, 12 or 13", for the works "Schedule 7 or 9" there were substituted the words "Schedule 7, 9 or 14", for the words "Schedule 8, 9 or 10" there were substituted the words "Schedule 8, 9 or 10" there were substituted the words "Schedule 8, 9, 10, 13 or 14", for the words "Schedule 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10" there were substituted the words "Schedule 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 12, 13 and 14" and there were included after the designation of Schedule 11 the following designations:

"Schedule 12 - 1 hour ticket parking

Schedule 13 - 10 hour ticket parking; residents', residents' visitors, business or operational parking

Schedule 14 - business (outer area), residents', residents' visitors or operational parking."

(j) in Articles 3, 5, 23 and 27 of that Order for the words "Schedule 5 or Schedule 6" there were substituted the words "Schedule 5, Schedule 6, Schedule 12 or Schedule 13";

- (k) in Articles 3, 5 and 28 of that Order for the words "Schedule 9 or Schedule 10" there were substituted the words "Schedule 9, Schedule 10 or Schedule 14";
- (1) in Articles 3, 6, 8(1), 9(2), 18, 20, 24(3)(b), 24(4), 24(5) and 28 of that Order for the words "Schedule 6 or Schedule 10" there were substituted the words "Schedule 6, Schedule 10, Schedule 12 or Schedule 13";
- (m) in Articles 4, 10, 15(8) and 23 of that Order for the words "Schedule 9 or Schedule 10" there were substituted the words "Schedule 9, Schedule 10, Schedule 12, Schedule 13 or Schedule 14";
- (n) in Article 6 of that Order for the words "Schedule 9" there were substituted the words "Schedule 9, Schedule 13 or Schedule 14";
- (o) in Articles 7, 23, 24(3)(c), 32(3) and 39 of that Order for the words "Schedule 9 or Schedule 10" there were substituted the words "Schedule 9 or Schedule 10, Schedule 13 or Schedule 14";
- (p) to the Schedule of Article 8(1) of that Order there was included the following table:

- (q) in Article 8(2) of that Order for the words "Schedule 1" there were substituted the words "Schedule 1 or Schedule 12" and for the words "Schedule 6 or Schedule 10" there were substituted the words "Schedule 6, Schedule 10 or Schedule 13";
- (r) there was included as paragraph 10 of Article 15 of that Order the following paragraph:
 - (10) In the case of a parking place referred to in Schedule 12, if on the leaving of a vehicle during the permitted hours in a parking bay there is on every ticket parking meter relating to that parking place a notice placed by any person duly authorised by the Council indicating that the ticket parking meter is out of order that vehicle shall be exempt from any parking charge provided that, if at least one of the said ticket parking meters is rectified or replaced not later than one hour before the expiration of the permitted hour, the vehicle is removed within one hour of such rectification or replacement. If the vehicle is not so removed the parking charge for a parking period of one hour shall be deemed to have been incurred and paid at

the time when the vehicle was left in the parking bay by the insertion of a coin or coins for the amount of that parking charge in a ticket parking meter relating to that parking place and all the provisions of this Order shall apply accordingly".

- (s) in Article 15(7) of that Order for the words "Schedule 6 or Schedule 10" there were substituted the words "Schedule 6, Schedule 10 or Schedule 13";
- (t) in Article 32(4) of that Order for the words "Schedule 8 (Part I) or Schedule 9" there were substituted the words "Schedule 8 (Part 1), Schedule 9 or Schedule 13" and for the words "Schedule 8 (Part II) or Schedule 10" there were substituted the words "Schedule 8 (Part II), Schedule 10 or Schedule 14";
- (u) in Article 34(3) of the Order there was deleted the words "Schedule 7" and there were substituted the following:

"Schedule 1, Schedule 2 (Part I), Schedule 2 (Part II), Schedule 3, Schedule 4, Schedule 5, Schedule 6 or Schedule 12 from 8.30 am until 9.30 am and from 5.30 pm until 6.30 pm or in a parking place referred to in Schedule 7, Schedule 9 or Schedule 14 between 8.30 am and 6.30 pm".
