Question 12	 Two points: 1. On Neighbourhood behaviours – I'm encouraged by what was said about the 'switching off' campaign from signage up to walls. My suggestion and request is: that we can have that, including the wardens, not only before the brewery development gets started, but before Hammersmith Bridge is next closed, with a priority for the Borough. Related to that, if there are wardens in the area, near that traffic build up, going into Chalkers Corner, maybe those wardens can be eye out for rogue cyclists as well? 2. I'm, aware of a Japanese School in Actor that has a walking train. A walking train is where kids are encouraged to walk from considerable distance away from the school because they are always being overseen by a group of volunteers, parents, staff and others. And could we consider that from very early on as you have rightly said, the school builds up to 1,200?

Question 13	I want to talk about green space relating to school – I want my kids to have green space to play and I think for me the question is: saving the green space for sports and recreation and as part of the heart of the community. Isn't that even more important as the population grows? What will the council do to actually protect the field, as is, or an AstroTurf? The way I think about is pretty simple, which is 1,200 kids, on an AstroTurf, meaning, they're playing just football, and you're asking 1,200 kids at break time to take time, to choose what sport they want to play. That's a recipe for disaster, they're going to spill out, on to the roads, and the pressure will be, back on the rail crossing, so I don't see us being able to change human behaviour, just by reducing the space they have to play. Actually, I think you should be looking at a smaller school, back to 600 again, or maybe less, or maybe even a primary school. I'm not convinced a secondary school is fit for purpose for that space because, for me, secondary schools need a lot of sporting grounds, whether its football, rugby, basketball, you'd want all of those things to be there, because we want them to not just actually go into a room to learn, we want them to be out there playing because it helps their learning as well. So for me the critical question is: what are you doing besides just squeezing every space for the school?

Question 19	The Village Plan 2010 said that the heart was taken out of Mortlake in 60's and 70's with the duel-carriageway and the mess that was left. If the brewery site wasn't being re-developed, I think that after the discussions in the previous meeting, there was a feeling something had to be done about the High Street. My concern is that an opportunity shouldn't be lost when the re-development of the brewery takes place to provide a link between the existing Mortlake and the new area. Otherwise, instead of a heart there, we'll have a clogged up centre, or arteries, we often look a four lines of traffic, parking on either side, parking on the pavement, and that isn't a very good thing.
	Safety is an issue around the level crossing, around the station. The introduction of Thompson House, entry and access from the station with forklift trucks, other builders lorries delivery to Tesco's being opened just the other side. What is the Council's responsibility for safety when giving permission for developments?
