Dear Resident / Occupier

East Twickenham Controlled Parking Zone (CPZ), Zone F Review

Earlier this year, we sought feedback from all properties in Zone F on whether to extend its operational hours/days (currently 10am to 4.30pm, Monday to Friday). We also consulted properties in Beresford Avenue on the possibility of this road joining the zone.

These consultations followed similar ones carried out in 2019 prior to the opening of the Lidl store and Deer Park School. Both the 2019 and 2022 consultations were undertaken in connection with the possible impact that the new store and school could bring to the area.

Zone F Consultation 2022 Results

The results of this consultation showed:

Existing Zone F area:

Out of 2336 properties consulted, 313 responded to the consultation via the questionnaire – a response rate of 13%
223 respondents (71%) prefer the CPZ to operate Monday to Friday (existing)
227 respondents (73%) prefer the CPZ to operate 10am to 4.30pm (existing)

Beresford Avenue:

Out of 27 properties consulted, 24 responded to the consultation via the questionnaire – a response rate of 89%
12 respondents (50%) wish to join Zone F
10 respondents (42%) do not wish to join Zone F

Decision and next steps on CPZ's future operation

Taking into account the above results, the decision has been made not to make any changes to the operational hours/days of Zone F but to add Beresford Avenue to the zone, along with the existing uncontrolled section of Park Road which was previously approved.

In early/mid 2023, the Council will be advertising traffic management orders to extend the zone to Beresford Avenue/Park Road and to propose some minor operational amendments to the zone. This will be followed by a replacement of all existing signage/lining. We will write to you nearer the time with the details of the next steps in the process.

Other East Twickenham schemes to be progressed in 2023

Please be informed of two additional schemes being progressed in this area during 2023:

East Twickenham (Richmond Road) Streetscene Improvements

Works will commence on Monday 9th January 2023. The first stage of the project will focus on the footway on Richmond Road (either side of the junction with Park Road) and the new entry treatment for Park Road. This part of the project is scheduled to last for approximately 10 weeks. Please note access to Park Road will be maintained at all times. Parking suspensions will be in place outside of Nos. 358-376 Richmond Road to maintain two-way traffic flow on Richmond Road. These parking suspensions will be separately signed in the week preceding the works. Pedestrian access to all shops will be maintained at all times.

Proposed contraflow cycling on Morley, Denton & Cresswell Roads

The Council is proposing to allow contraflow cycling along Morley Road, Denton Road and Cresswell Road. The intention is to formalise two-way cycling on existing one-way roads for motor vehicles. We will be consulting all affected frontages on these proposals early in 2023.


