

TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER, 1973

WHEREAS The Mayor Aldermen and Burgesses of the London Borough of Richmond upon Thames ("the Council") are satisfied that it is expedient in the interest of the proper planning of the area that development of the description hereinafter mentioned should not be carried out in the area of land more particularly described in the Schedule hereto ("the land") unless permission therefor is granted on application in that behalf made under the Town and Country Planning General Development Order 1973 ("the Order")

PURSUANT to Article 4 paragraph 3(b) of the Order the Council hereby direct that in respect of the land permission granted by Article 3 of the Order shall not apply to development of the following description:

Changing roof materials and alterations to the roof including dormer windows and roof extensions alterations to the fenestration in particular the removal of bay windows and the substitution of inappropriately proportioned windows and the rendering or painting of the brickwork of any facade being development comprised within Class I paragraph 1(a) and (b) and Class II paragraph 3 referred to in the First Schedule to the Order and not being development comprised within any other Class

THIS Direction shall remain in force for a period of six months from the date hereof at which time it shall expire unless it has before the termination of the said six months been approved by the Secretary of State for the Environment

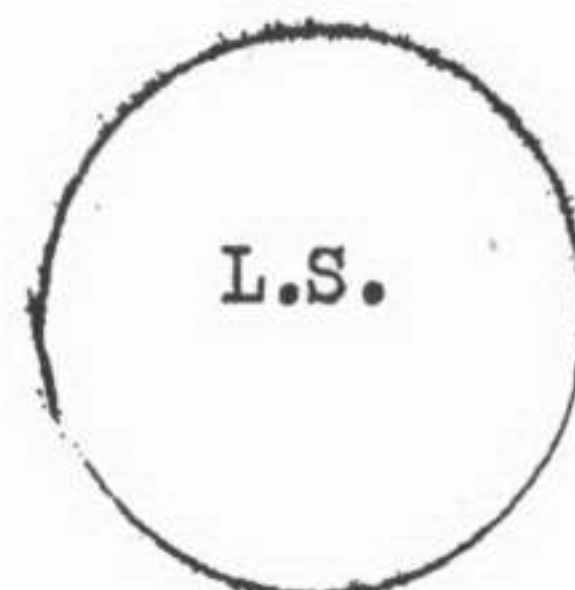

"THE LAND"

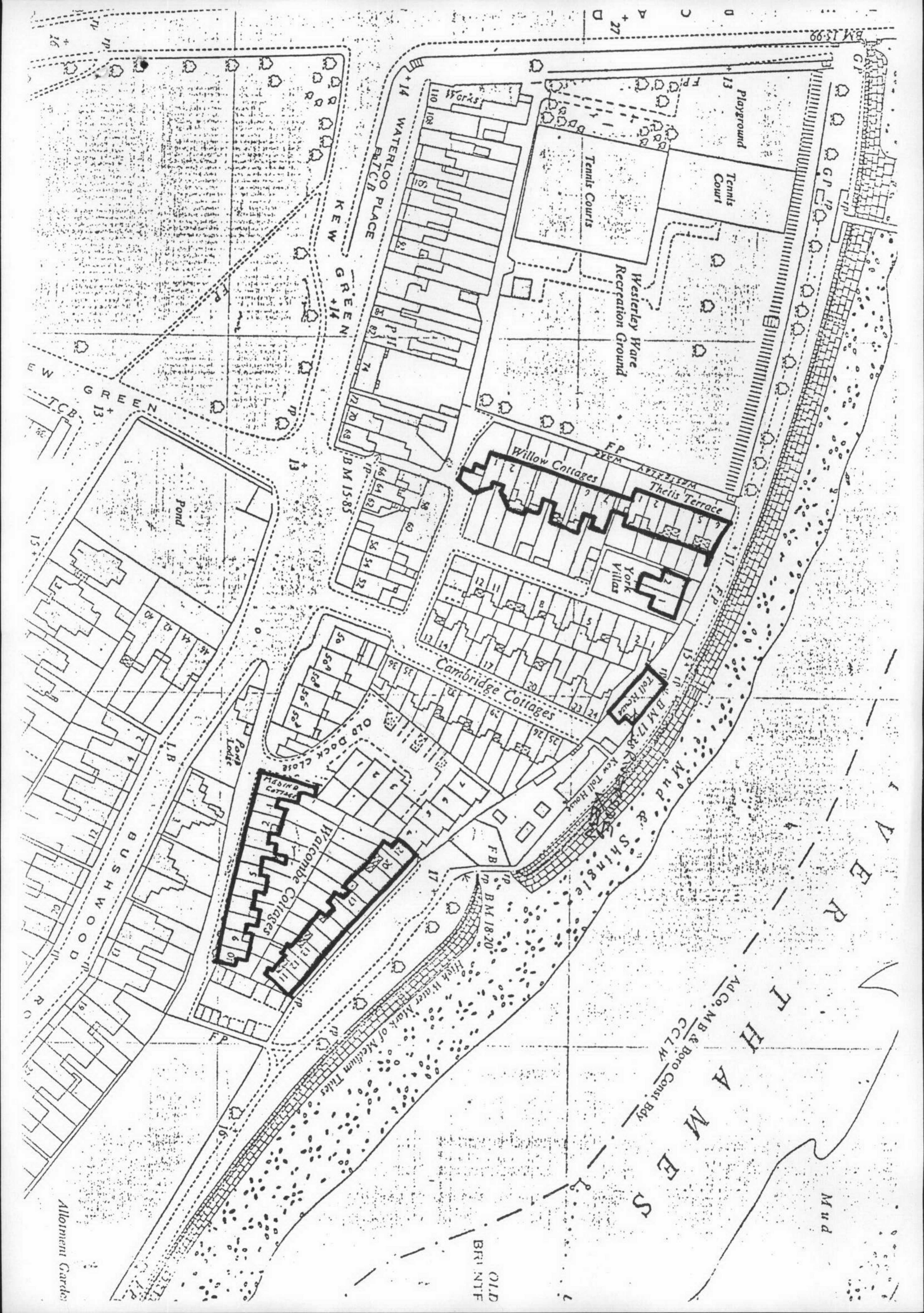
