Foreword

As Cabinet Member for Traffic, Transport and Parking I submit the updated Local Implementation Plan (LIP) for transport to Transport for London on behalf of Richmond upon Thames.

The Council has taken on board the comments received on the draft LIP from the community, Transport for London and other stakeholders, and has updated the LIP in order to gain Mayoral approval. The LIP Matrix in Appendix B is likely to provide a good starting point to ascertain the updates that have taken place in response to TfL concerns. Consultation responses from other stakeholders and Borough residents have also resulted in changes and it is hoped that the final LIP is suitable for approval.

The Council is committed to effective transport policies as part of its efforts to create a better environment for the people of Richmond upon Thames and London at large.
