**TOWN AND COUNTRY PLANNING (GENERAL PERMITTED
DEVELOPMENT) ORDER 2015**

**NOTICE OF DIRECTION UNDER ARTICLE 4(1) TO WHICH ARTICLE
5 APPLIES**

Notice is given that on 10th March 2016 the London Borough of Richmond upon Thames Council made a direction under Article 4(1) of the Town and Country Planning (General Permitted Development) Order 2015 (as amended) ("the Order").

The Direction withdraws the permitted development right granted by Class D Part 3 Schedule 2 of the Order for development consisting of a change of use of a building and any land within its curtilage to a use falling within Class A2 (financial and professional services) of the Schedule to the Town and Country Planning (Use Classes) Order 1987 from a use falling within Class A1 (shops) of that Schedule.

The effect of the Direction is that once it comes into force permitted development rights for this type of development are withdrawn and that planning permission will therefore be required for change of use from Class A1 to A2.

The Direction relates to defined zones shown hatched in red on the maps forming part of the Direction and being:

1. Parts of Richmond town centre
2. Parts of Twickenham town centre
3. Parts of East Sheen town centre
4. Parts of Broad Street, Teddington
5. Parts of High Street, Teddington
6. Parts of High Street, Whitton
7. Parts of High Street, Barnes
8. 125-145 and 54-102 Church Road, Barnes
9. 332-380 Richmond Road, East Twickenham
10. 50-80 High Street, Hampton Hill
11. 169-183 High Street, Hampton Hill
12. 92-100 Station Road, Hampton
13. 1-13 Wensleydale Road, Hampton
14. 1-3 Station Approach and 70-76 Milton Road, Hampton

15. Ham Parade, Richmond Road, Ham
16. 125-155 St Margaret's Road, St Margaret's
17. 109-119 St Margaret's Road and 2-24 Crown Road, St Margaret's
18. Station Approach and Station Parade, Kew
19. Parts of Friars Stile Road, Richmond
