Teddington Direct River Abstraction (TDRA) Project

Statutory Consultation under Section 42(1)(a) to (c) of the Planning Act 2008 and Regulation 13 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017

We are writing to you regarding the proposed Teddington Direct River Abstraction ('TDRA') Project ('the Project'). This letter has been sent to you to formally notify you of the statutory consultation on the Project which launches on **17 June 2025** and lasts for 10 weeks until **11.59pm on 26 August 2025**. We have a statutory duty to consult you, as you are listed as a statutory party under section 42(1)(a) to (c) of the Planning Act 2008 ('the Act') and/or Regulation 13 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 ('EIA Regulations').

The Project is being promoted by Thames Water Utilities Ltd of Clearwater Court, Vastern Road, Reading, RG1 8DB. As a statutory undertaker, we are legally obligated to provide water and sewerage services to our customers. This includes responsibility for maintaining public water mains and sewers, as well as treating wastewater.

The Project

TDRA is a drought resilience project designed to provide additional water capacity for London during drought conditions. It would operate intermittently, supplying up to 75 Ml/d when required. Modelling scenarios indicate the Project would typically only function during low river water flow periods in the River Thames, averaging once every two years, primarily between August and November.

The Project involves:

- Establishing a new abstraction intake on the River Thames approximately 350m upstream of Teddington Weir;
- Transferring the river water to the Lee Valley Reservoirs via the existing Thames Lee Tunnel;
- Recycling water using a new Tertiary Treatment Plant at Mogden Sewage Treatment Works;
- Transferring the recycled water through a 4.2km recycled water conveyance tunnel from Mogden to Teddington with an intermediate access shaft in Ham Playing Fields; and
- Releasing the recycled water through a new outfall approximately 180m upstream of Teddington Weir.



The Project would deliver enhanced drought resilience benefits from 2033 (for predicted 1-in-200year drought events). This is required to meet water demand for a projected population of over 10 million people in London by 2050, with growth predicted of over 100,000 people a year. TDRA is a strategically important water resource due to the social, economic and environmental significance of London, the South of England and UK. It will play a critical role in meeting the water resources needs and resilience of this large geographical region.

We sought and obtained a direction from the Secretary of State under section 35 of the Act which confirms that the Project will be treated as development of national significance for which development consent is required. We intend to make an application for a Development Consent Order ('DCO') to the Secretary of State for Environment, Food and Rural Affairs under Section 37 of the Act. It is anticipated that the proposed DCO will, among other things, authorise:

- The construction, operation and maintenance of the Project and associated development;
- The compulsory acquisition of land rights in or over land and imposition of restrictions, powers to override, suspend or extinguish rights over land and the temporary use of land;
- The application, modification and/or disapplication of legislation relevant to the Project including that relating to the compulsory acquisition of land; and
- Such ancillary, incidental and consequential provisions, licences, property rights, permits and consents as are necessary and/or convenient.

The Project is an Environmental Impact Assessment ('EIA') development as defined in the EIA Regulations. Therefore, we have prepared a Preliminary Environmental Information Report ('PEIR'), which will inform consultation and the production of an Environmental Statement.

Please also find enclosed a copy of the notice which publicises the proposed application, as required by Section 48 of the Act and Regulation 13 of the EIA Regulations.

The Statutory Consultation process

Our consultation runs for 10 weeks, from **17 June to 11.59pm on 26 August 2025**. There are many ways you can get involved, find out more about the Project and have your say on the proposals. We have prepared consultation materials to explain our proposals, which include:

Notice is hereby given that Thames Water Utilities Ltd of Clearwater Court, Vastern Road, Reading, RG1 8DB ('the Applicant') intends to submit an application to the Secretary of State for Environment, Food and Rural Affairs under Section 37 of the Planning Act 2008 for development consent ('the Application') for the Teddington Direct River Abstraction (TDRA) Project ('the Project').

TDRA is a drought resilience project designed to provide additional water capacity for London during drought conditions. It would operate intermittently, supplying up to 75 MI/d when required. Modelling scenarios indicate the Project would typically only function during low river water flow periods in the River Thames, averaging once every two years, primarily between August and November.

The Project involves:
